OHIO CHEEP OPERATIVES STARVE, TORTURE USLP SUPPORTER

CLEVELAND, AUG. 1 (IPS) -- MR. JOSEPH CAMERATTA, A WORKER AT THE FORD BROOKPARK PLANT NEAR HERE AND A SUPPORTER OF THE U.S. LABOR PARTY, WAS RELEASED FROM THE PARMA, OHIO JAIL THIS MORNING AFTER BEING HELD, STARVED, AND TORTURED FOR FOUR DAYS ON "DIS-ORDERLY CONDUCT" CHARGES. LEGAL ACTION AGAINST LOCAL POLICE AND ANY OTHER AUTHORITIES IMPLICATED IS NOW BEING UNDERTAKEN BY LABOR PARTY LAWYERS ON MR. CAMERATTA'S BEHALF, WHILE AN INTENSIVE INVESTIGATION OF FORD AND ROCKEFELLER'S INVOLVEMENT THROUGH THEIR COMMITTEE TO RE-ELECT THE PRESIDENT (CREEP) CONTINUES.

NR. CAMERATTA WAS SEIZED BY NINE PARMA POLICEMEN ON MONDAY, JULY 28, AFTER THE CAR IN WHICH HE WAS DRIVING WAS MRECKED IN A SUSPICIOUS ACCIDENT. MR. CAMERATTA, IN A DAZED CONDITION FROM THE ACCIDENT, HAD ENTERED A NEARBY BAR WHERE THE BARTENDER PHONED AN EMERGENCY NUMBER. INSTEAD OF THE AMBULANCE REQUESTED, THE NINE POLICEMEN ARRIVED. GOING THROUGH HIS POSSESSIONS WITHOUT EVIDENT REASON. THE POLICE DISCOVERED A TICKET TO A SPEECH BEING GIVEN IN CLEVELAND THAT DAY BY LABOR PARTY PRESIDENTIAL CANDIDATE LYNDON LAROUCHE. THE POLICEMEN STOLE THE TICKET AND ARRESTED MR. CAMERATTA ON CHARGES OF "DISORDERLY CONDUCT" WHEN HE PROTESTED.

AT THE PARMA JAIL, CAMERATTA WAS REFUSED PERMISSION TO USE HIS ONE PHONE CALL TO CONTACT THE LABOR PARTY. HE TELEPHONED A GIRL-FRIEND, WHO IMMEDIATELY CAME TO THE JAIL WITH THE \$300 INITIALLY SET AS BAIL. SHE WAS INFORMED THAT BAIL WAS THEREUPON RAISED TO \$1,0001 SHE LEFT, RETURNED THE FOLLOWING WITH THE LATTER SUM, -AND BAIL WAS THEREUPON RAISED TO \$3,0001 TWO LAWYERS SUBSEQUENTLY CONTACTED BY HER SECURED MR. CAMERATTA'S RELEASE AT 11:00 A.M. THIS MORNING.

WHILE IN JAIL. MR. CAMERATTA REPORTS THAT HE WAS DENIED MEDICAL TREATMENT FOR INJURIES FROM HIS MONDAY ACCIDENT, AND WAS DENIED ADEQUATE AMOUNTS OF FOOD. HE MAS PLACED IN THE "LAUGHING BOX" — A CELL IN WHICH VERY LOUD TAPES OF HUMAN LAUGHTER WERE PLAYED DAY AND NIGHT — AND KEPT THERE FOR THE ENTIRE FOUR DAY PERIOD. UPON RELEASE, MR. CAMERATTA COMPLAINED OF DIZZINESS, AND EXPRESSED THE FEAR THAT HE HAD BEEN DRUGGED.
