LABOR PARTY PREPARES TO EXPOSE FLINT DRUG-AND GUN-RUNNING NETWORK: PROMINENT LAWYER HARASSED

FLINT, MICH., JAN. 22 (IPS)—ON THE EVE OF THE LABOR PARTY'S EXPOSURE OF FLINT, MICH. AS A MAJOR NEXUS OF FBI-DIRECTED DRUG-AND GUN-RUNNING OPERATIONS, PROMINENT LAWYER MAX DEAN HAS RECEIVED INTENSE HARASSMENT FROM THAT VERY NETWORK. DEAN IS A MEMBER OF THE LABOR ORGANZIERS DEFENSE FUND7S ADVISORY BOARD AND IS PRESENTLY FILING SUIT ON BEHALF OF THE USLP AGAINST THE CONTINUATION OF ILLEGAL HARASSMENT ACTIVITIES BEING CARRIED OUT BY THE SPECIAL OPERATIONS BUREAU OF THE FLINT POLICE DEPARTMENT UNDER THE DIRECTION OF THE FBI.

THE LABOR PARTY HAD RECEIVED INFORMATION YESTERDAY THAT EXPOSED THE INNER WORKING OF FLINT'S "INVISIBLE GOVERNMENT,"
DOCUMENTING SPECIAL OPERATIONS BUREAU (SOB), U.S. TREASURY DEPARTMENT BUREAU OF ALCOHOL, TOBACCO AND FIREARMS (ATF) AND FBI INVOLVEMENT IN AREA GUN— AND DRUG-RUNNING OPERATIONS. THE LABOR PARTY INTENDS TO EXPOSE THIS INFORMATION AS PART OF ITS ONGOING CAMPAIGN TO IDENTIFY AND DISMANTLE THE U.S. JUSTICE DEPARTMENT'S TERROR APPARATUS. LABOR PARTY SPOKESMEN WERE SLATED TO TESTIFY ON THE FLINT OPERATION AT TODAY'S DETROIT CITY COUNCIL HEARINGS ON THE ILLEGAL ACTIVITIES OF THAT CITY'S LEAA—CONTROLLED RED SOUAD.

THE SOB

THE SOB IS RUN OUT OF THE HEAVILY FUNDED FLINT PROSECUTOR LEONARD7S OFFICE, WHICH ALSO OVERSESS THE ACTIVITIES OF THE LEAA-ORGANIZED CRIME TASK FORCE, AND THE FBI, ATF AND THE MICHIGAN STATE POLICE. IT IS RESPONSIBLE FOR "INVESTIGATING" CASES INVOLVING ORGANIZED CRIME, DRUG-RUNNING, GUN-RUNNING, PROSTITUTION—AND THE LABOR PARTY. ONE PARTICULAR DETECTIVE IS ASSIGNED TO ALL CASES INVOLVING THE LABOR PARTY AND ACTS AS THE DIRECT LIASON TO THE FBI.

THE SOB, AS MENTIONED ABOVE, HAS A NETWORK OF HUNDREDS OF "VOLUNTARY" INFORMERS WHO OPERATE WITHIN AUTO PLANTS AND COMMUNITIES. THE SOB FUNNELS DRUGS AND GUNS INTO THIS SAME NETWORK WHICH IS CONNECTED TO THE NEARBY MICHIGAN HEADQUARTERS FOR THE KKK.

THE SOB HAS STONEWALLED ON INVESTIGATING OVER 30 INCIDENTS

OF ATTACKS ON LABOR PARTY MEMBERS. AT LEAST TWO OF THESE ATTACKS WERE MADE BY TWO IDENTIFIED SOB OPERATIVES, LENNY BROWN AND WILLIAM BROWNING. BROWN HAD LAST YEAR ATTEMPTED TO INFILTRATE THE LABOR PARTY. BROWNING PHYSICALLY ATTACKED A LABOR PARTY MEMBER RECENTLY.

IN A RELATED DEVELOPMENT THE U.S. LABOR PARTY LEARNED TODAY LAT THE FBI-CONTROLLED MINUTEMEN AND THE KNIGHTS OF THE KU KLUX KLAN ARE PLANNING AN ARMED ATTACK ON LABOR PARTY MEMBERS IN THE READING. PA. AREA FOR SOMETIME ON FRIDAY. JA. 23.

ACCORDING TO ONE RELIABLE SOURCE, THAT ATTACK IS BEING PRO-VOKED BY LOCAL FBI AGENT DAVID ALLEN REILLY AND IS TO INVOLVE GUNS AND OTHER WEAPONS. THE SOURCE INDICATED THAT IT WAS TO BE CARRIED OUT AT ONE OF TWO ROUTINE LABOR PARTY DISTRIBUTION SITES —À LOCAL SHOPPING CENTER OR THE PARRISH STEEL PLANT.

LAST YEAR, THE LABOR PARTY HAD EXPOSED MASSIVE FBI-CONTROLLED GUN- AND DRUG-RUNNING OPERATIONS BEING RUN OUT OF READING. THE OPERATION, WHICH CONDUITED WEAPONS, DRUGS AND EXPLOSIVES TO VARIOUS FBI TERRORIST OPERATIONS, INVOLVED THE MAOIST REVOLUTIONARY UNION AND THE KKK, AND IS COORDINATED BY AGENTS OF THE FBI AND THE TREASURY DEPARTMENT'S BUREAU OF ALCOHOL, TOBACCO AND FIREARMS.

AS IN THE FLINT CASE. THIS NEW FBI ESCALATION COMES AS THE USLP HAS BROADENED ITS EXPOSURE OF THE FBI OPERATIONS THROUGH THE RELEASE OF A NEW LEAFLET ON ITS READING NEXUS.

LEGAL COUNTERPUNCH OFFENSIVE

HAVING ALREADY FILED A SUIT AGAINST SOB AGENT BROWNING, THE USLP WILL SHORTLY FORMULATE A BROADER ACTION AGAINST THE SOB. BASED ON THE PATTERN OF ONGOING DISRUPTIVE ACTIVITIES OF BROWN AND BROWNING. SINCE THERE IS A DIRECT OPERATING RELATIONSHIP BETWEEN THE SOB AND THE STATE POLICE, THE PARTY WILL ALSO UTILIZE THE RECENT MICHIGAN STATE COURT RULING WHICH AUTHORIZED A 60-DAY PERIOD WHEREBY SELECTIVE PETITIONERS WILL BE ABLE TO GAIN ACCESS TO THEIR FILES. FINALLY, THE CONNECTIONS BETWEEN THE FBI, SOB AND STATE POLICE ARE A BASIS BY WHICH THE LABOR PARTY WILL MOVE TO GAIN THE RIGHT OF DISCLOSURE OF THOSE AGENCIES IN ITS CURRENT SUIT AGAINST THE FBI IN DETROIT.
