#### "THE PARANOIDS ARE AFTER US!"

Dec. 4 (IPS)--Calls to government officials by IPS reporters have recently indicated that some of these gentlemen have had one too many briefings from the CIA.

On Dec. 2, an IPS reporter innocently called Mr. Robert Frances, the Director of "Mobilization Readiness" within the Department of Commerce, on the recommendation of a local Department of Commerce official. The reporter was inquiring about the recent training exercise for the National Defense Executive Reserve in Pennsylvania.

After the reporter introduced himself, Mr. Frances shouted, "IPS! Do you know Mr. Marques and Miss Wagner? They say they are from IPS and I know they're not."

Mr. Marques and Miss Wagner are both IPS correspondents. When Mr. Marques spoke to Mr. Frances, he did so as a concerned private citizen and did not identify himself as being with IPS. Miss Wagner has never spoken to Mr. Frances.

Frances then nervously added, "But if you want to know about the NDER, write me a letter with your questions. This information is public even to the United States Labor Party!"

# THREAT TO BLOW UP LABOR COMMITTEE OFFICE AND ASSASSINATE MEMBERS

NEW YORK, N.Y., Dec. 4 (IPS)--At 5:30 p.m. today, the National Caucus of Labor Committees (NCLC) national headquarters in New York City received the following telephone threat from a caller identifying himself as "Cacho," a member of the "Brigadas Anti-Comunistas":

"Is LALC there? I have a message for Fernando. I know him. I have four to five people from the Alianza Anti-Comunista Argentina [AAA: Argentinian Anti-Communist Alliance] in New York.

"I know Fernando Quijana. He has 48 hours to live, and I'll put a bullet in his head. Your group has printed things about us [AAA] and this is why we are going to get you. [repeated several times] I want Fernando Quijana. [repeated several times].

"You're [LALC] linked to MLN [Moviemento Liberacion Nacional, Tupermaros]. It was legal for you to print things about AAA in the U.S., but once you moved into our territory, we cannot tolerate this. We are going to bomb your office and attack your people in the street, and it is a shame that poor innocent slobs will have to suffer. You will be responsible for that. We have 9MM shells....We will assassinate your members."

The caller spoke in a hysterical and frightened fashion in an accent identified as Argentinian. The effect was that of reading from a prepared message. During the call, the caller spoke in both Spanish and English, repeatedly asking for Fernando "Quijana," the Spanish feminine form of Quijano, the name of the Labor Committee member.

The NCLC has informed the New York Police Department (mid-Manhattan South Precinct), New York Police Intelligence Division, and the Argentinian Embassy. It is investigating the caller's identity and/or organization.

The AAA claims credit for the murders of dozens of revolutionaries, trade union leaders, and liberals in Argentina. If indeed this organization has extended its operation to the United States, we will ensure that their murderous activities are brought to halt. Alternatively, the NCLC is investigating the possible connection of the caller to left countergang organizations such as the Socialist Workers Party, Puerto Rican Socialist Party, Puerto Rican Independence Party, Partido Revolucionario Socialista, or the Gusanos (the CIA-run Cuban refugee terrorist apparatus, which recently announced an increase of its activities against U.S. left organization).

# LABOR PARTY BREAKS ROCKY'S HOLD OVER NFO CONVENTION

MEMPHIS, Dec. 4 (IPS)--An international effort of workers and farmers is turning the National Farm Organization convention here into a defeat for Rockefeller. No matter what the eventual outcome of the proceedings, the lively briefings and debates initiated by a handful of Labor Party organizers with the more than 1000 assembled farmers representatives have upset the preparations of the Rockefeller-controlled NFO leadership to have the convention rubber stamp the Rockefeller's World Food Bank proposal.

In previous days, the organizers have briefed up to 50 convention delegates at a time in the lobby of a downtown hotel. Last night, eight farmers from different parts of the country joined the USLP cadre in a strategy session, based on their agreement with those discussions. Methods for placing the Labor Party's Emergency Food Bill on the convention floor were worked out, in the wake of the NFO 'resolutions committee" refusal to allow its presentation. Of great importance, the group also worked out ways to expand the organizing into such farm regions as South Dakota.

By contrast, the NFO bureaucracy has entered the convention with a noose around its neck, which the Rockefellers' promise to tighten should the NFO fail to endorse that family's program for an international "food bank" to carry out controlled, mass starvation. The Securities Exchange Commission has conveniently charged the NFO leadership with manipulation of membership funds, opeing the door to complete a Rockefeller takeover coordinated by agents of United Autoworkers (UAW) President and Trilateral criminal Leonard Woodcock.

At one point in the pre-conference debates, a pressured member of the NFO Board, Tom Conrade, intervened. "Your confusing the members," he charged. The assembled crowd of 100 farmers shut Conrade up, and the discussions proceeded.

The convention which begins today is already the focus of international attention through Labor Party organizing efforts. The efforts of workers and farmers on both sides of the Atlantic have produced a flood of telegrams to the delegates in support of the Emergency Food Bill from all parts of the U.S., Canada, Italy, and Germany. The Bill itself, which calls for massive expansion of food production, cancellation of farm debt, and emergency relief to the Rockefeller-starved Far East and Africa, is being introduced to the Oregon State legislature by representative Wally Priestly. At the same time, Sydney Von Luthor, a State Senator in New York, has telegrammed Memphis calling on the NFO to endorse the bill. United Nations representatives from Africa and the Far East are circulating copies of the legislation and watching the convention closely.

#### CANADIAN PRESS PUSHES FOOD SCARE

Dec. 2 (IPS)--The press in Canada is subjecting the Canadian population to false food scares as preparation for Rockefeller's planned food control:

\*The press has played up the claim of the St. Catherine's Fruit and Vegetable Growers Association that because of sales of produce to the United States there are shortages in Canada and up to 100 per cent prices are expected.

\*A small strike of meat graders in Ontario, whose picket lines are being respected by the meat inspectors, is being played up in the press as a key to the imminent meat shortages.

\*Quebec press and press in other regions are publishing scare stories about bread shortages and imminent rationing for Eastern Canada because of the grandhandlers strike, which has interrupted grain flows.

Earlier in the year, the Montreal Gazette carried scare headlines about the possibility of bread shortages in Eastern Canada because of the Great Lakes shipping disruptions and the continued outflow of Canadian grain from Montreal elevators to foreign countries.

# U.S. AGRICULTURE IMPLEMENTS PRODUCTION SLATED FOR THIRD WORLD DEVELOPMENT

Dec. 1 (IPS)--The U.S. agriculture implements industry is in the process of converting from the production of necessary farm implements to the production of road, dam and other heavy equipment for Rockefeller's labor-intensive redevelopment projects throughout the Third World.

The following developments indicate the operation that is underway:

\*The Iranian Department of Roads has purchased \$50 million of road building tractors and other equipment from International Harvester.

\*International Harvester is making construction equipment for use in the Soviet projects, most probably in Siberia, for mineral extraction and for use in Eastern Europe. The equipment will be used on unspecified "selected other foreign projects," according to International Harvester's New York office.

\*Massey-Ferguson has refurbished an old equipment building plant in Iran.

International Harvester, Massey-Ferguson and John Deere are the top three agriculture implements producers. All are Rockefeller dominated. Their directors participated conspicuously in the pre-Rome Food Conference in Toronto and at other Rockefeller policy organizing events. Their Midwest plants are notorious fo the degree of tight security around them, especially the 20,000 man Peoria Harvester plant.

#### Rocky's UAW Helper

Pat Greathouse, the UAW Executive Vice President for the Agricultural Implements division, has been the handyman on the job to keep UAW workers "subdued" through extensive plant security and brainwashing operations as the agriculture implements factories of the Midwest are restructured.

Recently Greathouse recommended that older agri-implements workers "choose" to take layoffs in spite of their seniority, as a way to get the "benefits" of extra leisure time. This would leave the rest of the younger workforce for heavy duty work assembling the earthmovers for Rockefeller's restructuring of the agriculture implements industry.

Greathouse is the "addiction abuse"--brainwashing--expert for the UAW. The UAW representative on the National Council on Alcoholism, he wrote early articles on labor-management cooperation to treat (brainwash) alcoholics and deviants in the plant.

#### ROCKY'S SHEIKHS BUY UP U.S. CATTLE INDUSTRY

Nov. 30 (IPS)--The highly productive U.S. cattle industry is being dismantled and exported, lock, stock and barrel to Rockefeller's Middle East "development" areas.

The public relations director of the Arizona-Colorado Land and Cattle Company--a major U.S. agribusiness encompassing ranches, feedlots and equipment manufacturing and sales--admitted this news in an interview with IPS this week. "Business in the American market has been bad for cattle," said the spokesman, but there has been a push into "international agriculture" in recent months.

Fifteen per cent of his company was recently purchased by a consortium of Rockefeller's Arab companies. The purchase was channeled through the Arab-owned investment company Triad SA of Luxembourg. A ranking American member of Triad, Maurice McGill, described the deal as "a good faith gesture"--in short, a first installment for Arizona-Colorado Land and Cattle's "technical expertise" in setting up agricultural ventures in the Middle East.

The linchpin in this phase of agricultural "restructuring" is Rockefeller's lackey Robert McNamara's World Bank, which is reportedly handling the financing for deals of this type.

The Arizona-Colorado Land and Cattle deal involved a \$200 million feasibility study for a cattle ranching, feeding and packing operation in the Sudan. Arizona-Colorado Land and Cattle is presently negotiating with "half a dozen" other Mideast nations, including Egypt, Iran and Abu Dhabi for agri-projects worth hundreds of millions of dollars. According to the public relations spokesman, the negotiations have focused primarily on cattle, though irrigation, engineering and construction are also under discussion.

This aspect of "deindustrializing" North American agriculture is proceeding hand in hand with the outright elimination of more than two million small and medium-sized farmers in the U.S. The cutting edge of this attack has been the Rockefeller-dictated credit squeeze which hit farmers at a time of record indebtedness and skyrocketing operating costs. As IPS reported in June, a Chase Manhattan spokesman confirmed at that time that the tightmoney policies were intended to collapse and consolidate 2.5 million American farm units into 300,000 by the end of the decade.

#### PLAN TO REDUCE DAIRY FARMS BY 25-30 PER CENT

NEW YORK, N.Y., Nov. 30 (IPS)--IPS learned today that the unprecedented \$18 million assessment on the Dairylea dairy cooperative is part of a plan to reduce U.S. dairy farms by 25 to 30 per cent. The plan, elaborated in a Cornell University policy report, calls for restructuring dairy farming so that only fluid milk is processed and distributed in the United States. Milk for drying as well as for daily-related products like butter and cheese are to come exclusively from Europe's Low Countries--Belgium, Luxembourg and the Netherlands.

Dairylea is a major dairy cooperative, serving the whole of the Northeast. The \$18 million assessment on Dairylea's membership was levied in response to the Springfield Bank for Cooperatives' refusal—as Dairylea's major creditor—to extend the cooperative further credit. The move, which will cost the individual dairy farmer between \$1,000 and \$10,000 depending on the volume of his production, is expected to bankrupt 10 per cent of Dairylea's members, or approximately 800 farmers.

Faced with this attack, Dairylea's newspaper has begun to push a "no risk lease cows" plan to its membership. Under this scheme, first exposed by IPS this summer, Chase Manhattan Bank has already bought up dairy herds from cash-strapped farmers and rented them out. A company called Shelburne Lease Corporation is presently fronting for this operation, which leaves farmers completely at the mercy of Rockefeller's banks.

New York is the second largest dairy state in the country (after Wisconsin). Fully 70 per cent of all agricultural revenue in New York State comes from dairy farming.

#### FARM PRICES FALL BY 1.5 PER CENT

Nov. 30 (IPS)--The U.S. Agriculture Department reports that farm prices declined 1.5 per cent in the month ending Nov. 15. The greatest collapse was in the prices farmers received for meat animals, down 4 per cent. Beef cattle prices were responsible for most of this decline, although hog, calf and sheep prices were also lower. Other farm products showing price declines were soybeans, oranges, upland cotton and corn, while farmers received higher prices for milk and tomatoes.

The meat price collapse is a months-long trend which reflects heavier slaughter rates glutting the market, as farmers move to liquidate their herds. Livestock farmers are hurting from the Rockefeller-engineered drying up of farm credit at a time when production costs have skyrocketed.

The decline in prices for feedgrains, such as corn and soybeans, is a new trend indicating sharp reductions in grain-feeding of livestock. This is one more sign that the present "meat glut" will turn into a meat scarcity by mid-1975.

#### CUBA LURED INTO ROCKY'S SUGAR CARTEL

Nov. 29 (IPS)--Cuba, the once-truculent workers' state, has been lured into the Rockefeller cabal's latest commodity cartel--the 20-nation Sugar Producers' Association.

As IPS reported previously, the short-term objective of the sugar shortage hoax was to lure debt-ridden Cuba out of the Soviet sphere of influence and into Rocky's hands.

The recent sale of 400,000 tons of Cuban sugar--at the grossly inflated world market price--to speculators instead of to the Soviet Union, as their contract stipulated, whetted Fidel Castro's appetite. An additional 20 cents per pound for his sugar on the condition that he join the sugar cartel was an offer Fidel could not refuse. (Cuba's debt to Argentina, Canada and other non-Communist countries stands at a staggering \$1.3 billion.) The eager Fidel decided to cut sugar consumption at home by one pound monthly per person so that he can export nearly all Cuba produces.

Rockefeller's sugar hoax has brought other short-term dividends. The sugar "shortage" generated such hysteria in sweet-

toothed Britain, for instance, that it is being used as an excuse to call in the troops to harvest their sugar beet crop. This same procedure was used already in Belgium.

Meanwhile, the press has cited all sorts of phony deals to blame the Soviet Union for their alleged collusion with the Arab sheikhs to stockpile sugar. This CIA-manufactured story is absurd. While the Arabs have accumulated nearly nine million tons of sugar over the last few weeks, total Soviet purchases for this period are in the order of a mere 500,000 tons.

If the cartel goes ahead with its plan to sell 15 million tons of sugar for \$24 billion, thereby raising the wholesale price from the current 63 cents to 80 cents per pound, by Christmas a pound of sugar will cost a dollar or more at the supermarket.

#### BANKERS CALL FOR LICENSE TO LOOT FARMERS

ST. LOUIS, Nov. 29 (IPS)—At a national agribankers conference here Nov. 25, bankers reaffirmed their commitment to strangle U.S. agriculture and they endorsed Rockefeller's program for a World Food Bank. Chomping at the bit for an across—the—board license to loot the farm sector, they also called for the repeal of existing ceilings on interest rates chargeable to farm—ers—the usury laws.

In most states usury laws prevent private banks from charging more than eight per cent on farm loans, and private bankers have refused to extend desperately needed credit to farmers. As the bankers see it, they can get a much higher return elsewhere.

As the various government-sponsored farm credit sourceslike the Farm Credit Administration--begin to dry up, panicky farmers are finding themselves trapped in the bankers' looting drive. As a professor at the notorious agricultural think-tank Cornell University told IPS in September, "Farmers aren't trying to keep the bank rate low, because they know they can't get any loans that way."

With farm commodity prices sliding from their earlier speculative heights, millions of American farmers are sitting ducks for the agribankers.

#### HEINZ' ANTI-TRUST TASK FORCE TARGETS FARMERS

Nov. 29 (IPS) -- In addition to the credit squeeze and the deliberate rise in feed, fertilizer and gasoline costs engineered via the Great Oil Hoax, Rockefeller's agricultural "restructuring"

drive intends to destroy the central farm marketing mechanism, the cooperative.

Under the guise of "anti-trust" probes, the coordinated watergating of farm coops is directed by H.J. Heinz III's "House Republican Task Force on Antitrust and Monopoly Problems." The task force's first target was "the food industry." "After all," said Heinz, "who should know it better than I?"

Heinz, a Republican congressman from Pittsburgh, is the son of H.J. Heinz II, chairman of the multi-billion dollar food company and a prominent spokesman for Rockefeller's mass starvation World Food Conference held in Rome earlier this month.

The task force was behind the months-long attack on the Associated Milk Producers, Inc., an attack that emerged from the original CIA Watergating of the Nixon administration.

Currently, the task force is taking the National Broiler Marketing Association and the Central California Lettuce Producers to task in an attempt to strip them of their anti-trust exemption.

The farm cooperatives walk a fine line legally: They are exempt from the traditional anti-trust rulings, but at the same time they are forbidden to engage in "other monopolistic practices."

The "anti-monopoly" attack is aimed to destroy every vestige of an independent farm marketing mechanism. This destruction of the agricultural infrastructure is preparation for bringing what's left of U.S. farm production and distribution under centralized Rockefeller control.

#### DAIRYLEA GOONS EJECT LABOR PARTY ORGANIZERS

Nov. 25 (IPS)--Goons ejected U.S. Labor Party organizers from tonight's meeting of Dairylea Cooperative members in Middleburg, New York. Most farmers attending were in a desperate mood--many of them drunk--since Dairylea had just decided to assess its members a total of \$18.6 million to make up its huge deficit. The farmers' rage has been diverted, in many cases, into swinish, anti-labor sentiments, typified by one farmer's comment: "You're from labor....How much will a worker pay for my milk?"

Those farmers, however, who paused for a briefing by Labor Party organizers on how Rockefeller engineered the farm credit squeeze immediately bought copies of New Solidarity. They wanted to read more about how the present pitting of farmers against worker-consumers can be overcome through the Labor Party's campaign for an emergency farm debt moratorium and expanded food production.

Pete Schuyler, who appeared to have been briefed in advance on the Labor Party by Dairylea top officials, led the expulsion of Labor Party organizers. This is the second Dairylea meeting from which organizers have been excluded, indicating that Dairylea officials are playing a criminal role in "protecting" their members from the only kind of organizing which can halt the collapse of dairy farming.

JAPAN: MIKI SELECTED TO SUCKER THE LEFT INTO AUSTERITY

Dec. 3 (IPS)--The search for a successor to watergated Japanese Prime Minister Kakuei Tanaka is over. According to press reports today Takeo Miki, former Deputy Prime Minister and head of Japan's Environmental Protection Agency, has been chosen to replace Tanaka. Once the "progressive" Miki is slipped into the Prime Minister's chair, his job will be to sucker the befuddled Japanese left into active cooperation with the new government's austerity policies.

Miki comes to his new job well-qualified. He is a former is director of the Economic Planning Agency, a key supragovernmental body charged with restructuring the Japanese economy. Miki's successor in that job, Saburo Okita, is a top Japanese member of Rockefeller's Trilateral Commission. Miki also served as head of the Ministry of International Trade and Industry, which is playing a leading role in preparing Japanese industry and workers to be shipped out to Rockefeller's "development" labor camps in the Third World.

As head of the Environmental Protection Agency, Miki led the push for zero-growth austerity in Japan. The EPA's anti-pollution rhetoric has spearheaded the drive to ship Japan's "polluting" factories and workers out of the country.

#### Dark Horse

Dark horse Miki was nominated for the Prime Minister's job after the ruling Liberal Party was deadlocked between the party's two leading contenders, Finance Minister Masayoshi Ohira and right-wing former Finance Minister Takeo Fukuda. Fukuda and powerful Yasuhiro Nakasone, present boss of the International Trade and Industry Ministry, then threw their support to Miki. Earlier, it was Miki and Fukuda who led the attack on Tanaka when the two walked out of the cabinet this summer.

As the leader of the reform wing of the Liberal Party, Miki is the perfect Mr. Clean to lure opposition parties, including the Socialists, into a coalition government. Miki's populist aura is heightened by his support of detente with China and his consumerist policies as head of the Environmental Protection Agency. In addition he is reputed to be free of the stench of big business ties. But informed sources have confirmed that leading Japanese capitalists, satisfied with Miki's past performance, are backing him now precisely because of his ability to castrate the left-wing parties.

# STEEL COMPANIES REVOKE SUB-BENEFITS FOR COAL LAY-OFF VICTIMS

Dec. 3 (IPS)--Trilateral Commission agents I.W. Abel and Leonard Woodcock are applying "shock treatments" to hundreds of thousands of recently unemployed steel and auto workers in the form of "sudden revelations" that they will be denied their Supplemental Unemployment Benefits (SUB pay).

Of the over 180,000 steelworkers laid off by the Big Steel Companies, U.S. Steel and Bethlehem, and the thousands more laid off by smaller steel companies, no one is receiving SUB pay, even though United Steelworker bureaucrats explicitly told workers before the miners' strike SUB pay benefits were assured in the event of layoffs ensuing from a coal strike. Now, steel workers demanding the SUB survival pay are told to go home and read their contract. These workers have found that their set-up "contract" allows for revocation of SUB funds in all layoffs due to energy-related strikes!

Abel and Woodcock are attempting to reduce once productive auto and steel workers to terrified, grovelling infants who will be ready to accept the next phase of Rockefeller's program for the deindustrialization of North America: relocation to a concentration camp "development" project, a slave labor job in a public employment program, deathly speedup in a few remaining steel mills - or starvation.

The SUB plans in both auto and steel were consciously set up back in the 1950's under the guidance of Rockefeller Nazi-labor front planner, Murray Lattimer, to be used as a weapon against auto and steel workers in a depression period. In the case of the United Steelworkers SUB contract, SUB pay is auto-matically suspended under several conditions including: "strikes, slowdowns, work stoppages, picketing or concerted action at any operation of the Company, or of any labor disputes of any kind involving persons employed by the Company" (the Company here referred to is U.S. Steel).

The present coal strike fits neatly into this category since over 55 percent of all U.S. coal mines are directly owned by steel companies holding SUB pay contracts with the USWA. What horrified steel workers are watching unravel before their eyes is Rockefeller's depression contingency plan #1: provoking a coal strike through his agents in the labor unions which is simultaneously used as the pretext for mass layoffs and suspension of unemployment benefits.

In addition, all USWA SUB pay contracts specify other similar contingencies such as "strikes, slowdowns or labor disputes involving persons employed by transportation or utility companies which directly interferes with production or the ingress or egress of material or product at the operation where the layoff occurs." Stated more clearly: any labor

- whether provoked by Rocky's agents or legitimate strikes by workers against production cutbacks under depression conditions - in energy or energy related industries or transportation will automatically revoke the SUB plans. And these are the industries most directly under the Rockefeller family's control! The language of the USWA's SUB pay contracts is only slightly more subtle than the infamous west coast Longshore contract of 1960 which states that their guaranteed annual income fund, which covers all benefits, pensions, etc., will be automatically suspended in the event of an "economic decline."

More important, however, is the fact that the USWA contracts suspend SUB pay only when other workers and not ther Company or Rockefeller can be cited as the immediate cause for production cutbacks and layoffs. Contracts like this could only be mapped out in the war room of Rockefeller and his labor agents.

#### CIA CAUGHT IN THE ACT: PSYWAR MAKES THE NEWS

Dec. 3 (IPS) -- The CIA had its press prostitutes working over-time making the news last week.

A Baltimore TV station gave live coverage Nov. 29 to an explosion in Maclean, Va. that demolished a one-family house. When the reporter asked a woman in the family, "And when did this bomb go off" the woman replied, "Bomb, what bomb?" She added: "There was an explosion, but we didn't say that it was caused by a bomb."

But the bomb story didn't die in Baltimore. The New York Times tried a more subtle tactic. Along with an Associated Press picture of workmen in hardhats searching through the rubble of the devastated home, the Times noted in a caption that the explosion "may have been caused by a bomb."

#### Fallacy of Composition

Significantly, the picture was juxtaposed to an article on rank-and-file opposition in the United Mine Workers union. The psywar message was clear. Using a press trick known as Fallacy of Composition, the CIA-seasoned New York Times intended its readers to associate mineworkers with bombs. This tactic is similar to subliminal suggestion.

When IPS called the Times to find out who decided the layout of the page in question, a reporter who identified hims self as "Mr. Clerk" would not say. Interestingly, Mr. Clerk claimed that the unsigned article, which was labled as an AP release matching the AP photo, actually was written by New York Times reporter Ben Franklin.

# THE DEMISE OF WILBUR MILLS: WHAT HAPPENED IN LITTLE ROCK?

Dec. 3 (IPS)--The pathetic degeneration of the once powerful Chairman of the Ways and Means Committee, Wilbur Mills, like the case of Richard Nixon himself, is being obscenely plastered on the front pages of the nation's press for one reason only. The Rockefeller cabal wants everyone to get the message: no one independent of Rockefeller will be allowed to survive.

Those interested in turning this bit of calculated mockery of all legal government and any human self-respect around: it is only necessary to ask a few pointed questions:

- 1) What happened to Wilbur Mills in Little Rock, Arkansas, where he went for a back ailment several years ago and from which he returned, according to many observers, a "changed man?" Who were his doctors? What was his medication?
- 2) What is happening to Mills at Bethesda Naval Hospital?
- 3) Who is Mills' doctor; what are his connections to the Rockefeller cabal; and what drug is it that has "made him feel drunk" since it was prescribed for his heart condition?

#### ROCKEFELLER FUNDED ANGELA DAVIS BOOK

Dec. 3 (IPS)--The "Arthur Goldberg" book, by which Nelson Rockefeller became known as a man of literary interests, is not the only book of political import connected to the Rockefeller name. IPS learned recently of another and more famous publication. In this case, publication was arranged through the Third Press-Joseph Akpaku Publishing Co., a CIA-run publishing house, funded by the Rockefeller-controlled Ford Foundation, the Rockefeller-controlled New World Foundation, the Rockefeller family's Chase Manhattan Bank, and the CIA's Field Foundation.

The book is If They Come in the Morning, by the heroine of the Communist Party USA, Angela Davis.

Drawing on the above sources, Third Press-Okpaku provided over \$100,000 to assure publication and wide publicity at a very critical point in Miss Davis' meteoric rise to fame as a freedom fighter.

New Solidarity has documented how the CIA used the CPUSA's recruitment-drive around Angela's notoriety to flood that organization with agents and take total control of its policies. A smug Ford Foundation spokesman, who was asked a few days ago whether there had been any hesitation in bankrolling IF They Come In the Morning, replied readily: "No problem at all."

# FANG'S COMPUTER PRINTOUT GIVES ETHICAL OK TO GENOCIDE

NEW YORK, Dec. 3 (IPS) -- IPS has received a copy of a report -- "The Ethics of Humanitarian Food Relief" -- prepared under the direction of Zero Growther and computer/man Jay W. Forrester at the Massachusetts Institute of Technology which puts the ethical seal of approval on Rockefeller's mass starvation policy. The report is a computer printout and concludes that the dispensation of food relief is immoral.

Inspired by the Rockefellers, the computer study addresses the so-called Fourth World mass starvation policy. The "Fourth World" tactic is an eminently rational policy from the Rockefellers' sub-human standpoint of capitalist cost efficiency. First introduced as a form of the wartime practice of "triage" where Army physicians allowed the most seriously wounded to die in order to devote medicine and skills to the rest, the mass starvation policy nonetheless required a more convincing moral justification to guarantee its tacit acceptance by the working class of the advanced sector.

Dimly aware that their own particular necrophiliac brand of "morality" was not likely to sit well with workers, the cabal subcontracted the job to their pet computerized cannibal, Forrester. Employing the infamous garbage-in-garbage-out computer technique, Forrester's proteges fed the Zero Growth program into the MIT computer, followed by the question of food relief or no.

The answer--food aid is unethical--is as pathological as the Zero Growth assumptions it is derived from. The logic of this insane Zero Growth is that if you feed people now they will only continue to proliferate so that when you cut off food aid five years later, the death rate will be even more catastrophic.

The sole "ethical" options derived from the Zero Growth equation are: 1) starve them now, or 2) give them some "development" assistance on the condition it is combined with strict enforcement of massive population control--precisely the genocidal formula now being applied to the Indian subcontinent, Pakistan, and sub-Sahara Africa.

# TWA 727 CRASHES INTO SHADOW MILITARY GOVERNMENT

Dec. 3 (IPS) -- A TWA 727 jet crashed into a mountain in Virginia two days ago, killing 93 people. This catastrophe became the immediate pretext for the CIA press to give widespeead publicity to a nearby underground site of the emergency military government in the wings, run by the Office of Preparedness.

While both the Washington Post and the New York Times ran detailed gory accounts of the accident, the Post in particular zeroed in on the "secret government installation" known as Mount Weather located near the scene of the crash. The Post described Mount Weather as "the sort of top secret mountaintop retreat Ian Fleming was always dreaming up for James Bond." Known as "the Underground Pentagon or The Rock, Mount Weather... is one of several alternate command posts for use in the event of an atomic attack on Washington and is presently used as a highly classified communications base for the Civilian Intelligence Agency--part of the CIA's worldwide communications network," says the Post.

Calling the installation "the government's worst kept secret," the Post regaled its readers with tales of hikers "pausing to gawk through its high, barbed-wire topped fences at the signs and blinking lights warning people to stay away." According to the Post, fox hunts often intrude on the installation flushing out swarms of whistle-blowing guards.

This harmless tongue-in-cheek account merely covers the serious threat OP poses to the working class.

#### RELOCATION OF HOUSTON SUBURB PLANNED

Dec. 3 (IPS)--The Army Corps of Engineers announced today plans to relocate an entire suburb of Houston, which is situated on a flood plain rather than build a "costly" dam to prevent flooding. Fifteen hundred people will receive relocation subsidies under the Uniform Relocation Assistance and Real Property Acquisitions Act of 1970. Asked what the government would do if people refused to move, a spokesman for the Army Corps of Engineers (ACE) openly admitted, "Ultimately we could rely on the right of eminent domain and just move them."

The ACE spokesman continued bluntly, "What we would eventually like to do is set up something like a Relocation Agency within HUD which would work with a community prior to relocation, would get them used to the idea and would help people find suitable alternate housing."

# CANADA'S WORKERS IGNORE BORDER VOTE LABOR PARTY

NIAGARA-ON-THE-LAKE, ONTARIO, Dec. 3 (IPS)-- Nearly one in every ten voters in the Dec. 2 alderman elections here registered their support for North American Labor Party candidate Lucylle Boikoff; of the 3632 voters, 343 voted labor. This vote in an area dominated by auto and paper workers, along with fruit and vegetable growers, continues the destruction of the Rockefeller border between the U.S. and Canadian working class, already high-lighted by the recent 14 percent vote for

the NALP candidate for mayor in New Westminster (Vancouver), British Columbia.

A handful of Canadian NALP organizers, supported by organizers from Buffalo and Detroit carried the Niagara-on-the Lake campaign throughout the highly industrialized Golden Horseshoe area. The Labor Party drive countered a barrage of nationalist psywar aimed at cutting Canadian workers off from their American class brothers.

In the Toronto mayoral elections on the same day, NALP candidate Richard Sanders received 1.2 percent of the vote as did Manuel Lumbreras, NALP candidate for alderman. This amounted to 1454 votes for Sanders (no precinct breakdown is available at the time of this report). In a borough run by Rockefeller radicals where Zero Growth is stated policy and the population is mainly lumpenized or petty bourgeois, these nearly 1500 Labor voters represent a fighting base for the working class and a significant break in a nearly totally CIA-controlled environment.

The importance of the NALP's return can be judged against the press campaign to discourage the working class from voting or thinking seriously about politics at all. Day after day, the elections were portrayed as a farce, with no issues and nothing to vote for, in hopes of keeping workers away from the Labor Party campaign. The outcome was that the voter turnout was 27 percent, the lowest since 1942. The CIA succeeded in getting an 80 percent mandate for the incumbent stooge; more ominously, the openly fascist Western Guard finished second with 5600 votes, while joke candidate Rosy the Clown finished fourth. The only candidate given straight coverage as a socialist was that of the proto-fascist LSA, an affiliate of the National Socialist Workers Party who finished third.

In the months ahead leading to this spring's provincial elections the NALP will pull Toronto's 1500 Labor voters and others into the Labor Party's continent-wide working class machine. Andre Doucet, NALP candidate in last summer's provincial elections in British Columbia and representative of the recent NALP campaign in New Westminster, is touring through Washington and Oregon briefing workers on the significance of the vote in New Westminster and the international battle which the working class faces. The tour will take him to unemployment centers and plants in Seattle, Aberdeen, Tacoma, Longview, and Portland.

#### ARABS SENT ON BUYING SPREE

Dec. 3 (IPS)--Last week the Rockefeller Sheikdom of Kuwait picked up an attractive asset for its investment portfolio, which until now has been dominated by real estate and short-term paper investments. Speculation about the mystery buyer of \$300 to \$400 million worth of Daimler-Benz stock ended when

the Dresdner Bank, one of the three West German "big" banks, revealed that it had sold the shares for the Quandt family to Kuwait, not Iran as had been suspected. With this purchase of about 14 percent of the second largest automobile corporation in West Germany, Rockefeller financial interests have gained effective control of another one-time giant of West German industry through their Arab front-men.

The U.S. auto industry was nottleft out. Chrysler, which is going out of business at home, won a half billion dollar contract from the Iranian state automobile manufacturer for plant and equipment plus "know-how." Iran National's target is a 90,000 car annual capacity by the end of this year, 150,000 by next Februrary, and 500,000 by 1980, by which time it will be one of the world's largest auto makers and Detroit will have turned into a ghost town.

The Shah is also so anxious to buy a batch of Lockheed Aircraft's C5A military cargo planes that he has offered to pay for the reopening of the C5A military production line, which would involve an outlay of about 175 Million dollars. Negotiations on this deal involving the Iranians, the U.S. Defense Department, and Lockheed are now under way.

Another Arab businessman who has been getting a lot of attention in the press lately is Adnan Khashoggi, who was described as a "fast, medieval kind of operator" to IPS by an expert at the American-Arab Association for Commerce and Industry. The most recent addition to his obscure Triad Holding Comporation empire was one-third interest in the First National Bank of San Jose, California bought for \$14 Million last week. Despite his notoriety as an independent entrepreneur with an eye for "anything that makes money," khashoggi has always been very responsive to the will of King Faisal. Last spring, Faisal turned over to Khashoggi a \$20 million Eurodollar loan to Sudan which the Saudis had underwritten, and Khashoggi proceeded to manage the loan in a way that would "keep King Faisal happy." Khashoggi's "independence" appears to be as illusory as that of Rockefeller's collection of Sheiks.

#### ROCKY STAGES RUN ON GOLD

NEW YORK, Dec. 3 (IPS)--Rockefeller's man at the Treasury Department, William "Simple" Simon, triggered a collapse in gold prices today with an announcement that the United States would sell off part of its gold stock to depress the international price of the metal.

During the last several weeks, the gold price has risen to an all-time record, in anticipation of the repeal of laws which forbid U.S. citizens from owning gold. Simon said, however, that any inordinate demand in the United States would be met by Treasury gold sales.

In response, the gold price declined a whopping \$9 per ounce on the London market, settling at around \$170 at the afternoon fixing.

Behind the Rockefeller financier faction's efforts to bid down the price of gold is a confidential plan to use the world's gold supply as the centerpiece in a new fascist world monetary system.

The Rockefeller scheme, IPS has reported, involves the indexation of regional currency blocs to various commodities, especially oil, using both gold and the IMF's special drawing rights as a changeable standard of value.

Last month, IPS has learned, Rockefeller representatives proposed a "world gold bank" to finance East-West trade, with contributions from the Soviet Union, Western Europe, the United States, and the OPEC nations.

In a related move, Italian central bank deputy Rinaldo Ossola proposed that Europe should finance its \$20 billion oil deficit by giving the Arabs bonds payable in a certain number of ounces of gold, using the International Monetary Fund as a broker and underwriter.

Today, the New York Times claimed that the Saudis had expressed an interest in the Ossola proposal. On May 31, Ossola circulated a similar proposal, involving the exchange of European gold for the IMF's Special Drawing Rights at close to the market price for gold. The earlier proposal was first advanced in an October, 1973 report of the Rockefeller family's Trilateral Commission.

Both these plans aim at giving central financial institutions a virtual monopoly over the use of the world's gold supply, under Rockefeller control. Their concern, however, is to batter down the terms of soaking up this gold. Simon's announcement today is aimed at holding down the market gold price until every outstanding ingot is under Rockefeller control.

#### PLAN A LATIN REGIONAL FASCIST BANK

Dec. 3 (IPS)--Felipe Herrera- the ex-president of the Inter-American Development Bank, speaking before 800 representatives of Latin American banking, government and business circles in Porto Alegre, Brazil called for the economic integration of the continent through the formation of a central Latin American bank based on their \$20 billion currency reserves. Herrera claimed that Latin American currency reserves exceed those of the United States, the EEC, Japan, or Canada. That way, he said, "we could resolve by telephone the economic problems of Uruguay," for example. He further suggested the creation of a single, regional Latin American currency, since "we have reached the stage of monetary independence of Latin America."

Thus, as the CIA detonates a Chilean-Peruvian war to oust the last remaining neanderthal opposition to "fascism with a democratic face," Rockefeller's supranational aim in Latin America is gearing up to sieze fascist control of the economy.

In giving his support to Herrara's proposals, Jeffrey L. Morby, Vice President for Latin America for the First National Bank of Boston, was even more explicit in stating Rockefeller aims: "A Central Latin American Bank, in my opinion, is a reasonable idea... It is necessary to ask ourselves if the capitalist system is functioning properly. I, as a capitalist, believe that it is not. I believe that it requires certain modifications such as, for example, that the State—in concert with business and labor—should decide which are the priorities of society... It is necessary to plan the growth of the world... Within this plan, I have no doubt that business is approaching a new era that I would call social capitalism... If there can be one conclusion drawn from this conference, it is the idea that the Latin American countries must reactivate and push much harder for Latin American integration."

Such a new Latin American economic and political body is already nearly in existence. With the calculated collapse of the OAS, Rockefeller's agents in Latin America, in particular Mexican President Luis Echeverria, have been calling for the formation of a Latin American Economic System (SELAM) which would explicitly exclude the U.S. and include Cuba. Already Mexico, Venezuela, Cuba and Jamaica have given their backing, and joint Mexican-Venezuelan teams of organizers are stumping the continent to organize support for it.

Mexico's Secretary of National Patrimony, radical Horacio Flores de la Pena, recently laid out the real meaning of SELAM: "It's a kind of exclusive club of Latin America, to which admission cards will be granted only to those who struggle for their economic independence, for their development, and who have distinguished themselves through their struggle against the multinational companies" -- that is, those who will push Rockefeller's Various raw materials hoaxes.

#### PRESS FABRICATES REPORT OF IRAQI ATTACK ON KUWAIT

Dec. 2 (IPS)--A high-ranking Kuwaiti government official vehemently denied the claims made by the Washington Post and United Press International today that Iraq had made military advances against Kuwait. The whole idea is "preposterous," the official said, "there isn't a scintilla of truth in it."

Further checking by IPS with Iraq and other Arab countries confirmed that the stories of Iraq's attack were simply concocted by the press. The false dispatches represent an escalation in the psychological warfare directed against Iraq, the only Arab state to maintain strong ties with the Soviet Union and openly to oppose Rockefeller's consolidation of the Mideast.

This latest psywar comes on the heels of a "familiarization" tour through the Persian Gulf States by ex-CIA head Richard Helms, now Ambassador to Iran, and a group of U.S. military officers. An official from the State Department told IPS that the trip is Helms' "own business."

Helms, the CIA's man on the spot who organized last year's Mideast War and Oil Hoax, is reactivating his role in this present swing through the Persian Gulf. With the announcement of Saudi Arabia's takeover of oil assets from the oil companies and the heating up of a fifth Mideast war, Helms is firming up "Arab Unity." This is a code word for the controlled environment that produces policy for oil pricing, regional development projects and defense.

Iraq is the major kink in this plan to turn the Mideast into Rockefeller's phony, new advanced sector. After Helms' briefing, Saudi Arabia and the Gulf sheikhdoms, all well equipped militarily by the U.S., are prepared to hold a "confidential" summit meeting. Coordinated by King Faisal, the summit intends to firm up an Arab Power Bloc for regional defense and development, squeezing Iraq even further into a corner.

Last week, the U.S. aircraft carrier Constellation and two destroyers visited the Gulf area, and CIA director William Colby unofficially stopped off in the Gulf region last month. Reportedly, France has resumed diplomatic relations with Oman this year and has sent ships to the mouth of the Persian Gulf. At the same time, British warships are making what they call routine visits to the area.

#### HARTFORD PROCESS HIRES IAM LOCAL

HARTFORD, Dec. 2 (IPS) -- The International Association of Machinists (IAM) in this city is not a trade union organization, IPS established today. The main local, operating out of the United Aircraft Pratt-Whitney works here, is merely a subdivision of Hartford Process, the CIA-connected counterinsurgency front of this city's insurance companies.

Hartford Process' control of this IAM local was key in diverting a recent strike threat at Pratt-Whitney. More important, Hartford Process is publicly preparing an apparatus built on this ersatz labor union which will lead to mass speedup, recycling and relocation of area workers in the months just ahead.

Hartford Process employs the IAM unit as an arm of its workforce-recycling department, the Hartford Area Manpower Planning Board (HAMPB), which controls IAM operatives through the Department of Labor Education at the University of Connecticut. This agency is primarily a brainwashing clinic which boasts of having "processed" over 6,000 area shop stewards and bureaucrats in the past year, including those in the IAM at Pratt Whitney.

This ugly story began to emerge when New Solidarity investigated a recent IAM strike threat at Pratt Whitney. The announcement had raised high hopes among United Aircraft workers in Canada's Quebec province that their own bitter year-long strike might take a turn for the better. The Canadian workers members of the United Auto Workers (UAW), had struck United Sircraft's Longueuil plant on the outskirts of Montreal last January. The company imported 1600 scabs and shipped the reamining work to Pratt-Whitney in Hartford. The IAM unit scabbed, ignoring periodic protests and pleas for a sympathy strike from the locked-out Canadians.

Only when their own local contract negotiations began one week ago did the Hartford IAM finally threaten to strike. But the deluded hopes of the Canadians were dashed when the IAM unit settled two days ago for a limited Cost of Living clause and unlimited speedup.

When New Solidarity telephoned IAM headquarters prior to the settlement, IAM drones dumbly referred all questions to MR. David Pinsky of the University of Connecticut's Labor Education Department. Pinsky, a Hartford Process operative sitting on the Hartford Area Manpower Planning Board, was in charge of IAM "strike strategy."

When queried, however, Pinsky spoke only of the company's strategy. United Aircraft would farm out the work to many small machine shops, he said. They would be inconspicuous, so as

not to force the IAM to keep up appearances by picketting these shops. The subsequent acceptance of the speedup settlement by Pratt-Whitney workers rendered Pinsky's plan unnecessary.

"Strike strategist" Pinsky's position on the HAMPB gives him a key role in dispensing Comprehensive Employment and Training Act (CETA) funds to ready scab-labor for area companies. Official control over th funds is held by the Hartford City Manpower Board, which needs approval of all pecuniary decisions from a city council committee headed by CIA front-man Suissman. Suissman sits on HAMPB, and approves only City Board decisions corresponding to plans made by Hartford Process through HAMPB.

United Aircraft is consequently a major recipient of CETA monies, which it is using to train scab-labor for the Pratt-Whitney works. When Pratt-Whitney puts mass layoffs into effect in early 1975, the workforce will get the company's "Canadian treatment" as CETA workers trained by IAM operatives are recycled in to replace them.

New Saolidarity and IPS have thus far been unable to reach the IAM's "chief negotiator" of the recent settlement, Justin Ostrow, for his comments on this criminal arrangement. Ostrow may be expected to add to the picture from the knowledge he has gained as a member of the Board of Directors of Hartford Process.

# INTENSIVE SECRET TRAINING PREPARES MILITARY GOVERNMENT-IN-THE-WINGS

NEW YORK, Dec 2 (IPS)--On November 6 a group of carefully selected businessmen from throughout the eastern United States were brought to Lancaster, Pennsylvania to engage in three days of secret government training. They are members of the National Defense Executive Reserve (NDER), one of the arms of a growing "civil defense" octopus in the Federal Government.

According to a spokesman for the New York-New Jersey Region of the U.S. Department of Commerce, NDER executives will be instrumental in the government's efforts to "get the economy moving quickly" after a "chaotic situation" or "catasstrophy" that requres a government takeover. The spokesman told International Press Service reporters last week that the Lancaster, Pa. training exercises had been attended by military men and officials of the Defense Civil Preparedness Agency of the Department of Defense.

One military man known to IPS to have attended the Pennsylvania training is ex-Strategic Air Command General Leslie Bray now Director of the Office of Preparedness operating out of the General Services Administration—which is not even formally under the executive branch of the U.S. government. When reminded that he must have seen General Bray in Pennsylvania, the

Commerce Department spokesman who attended the training replied that "it's not General but Mr. Bray - he retired 2 or 3 years ago!"

#### CANADA MOVES TO RELOCATE UNEMPLOYED

Dec. 1 (IPS)--The Canadian Manpower Department has launched major pilot projects in job training and "work attitudes improvement" for unemployment insurance recipients. These moves are part of concerted drives to slot all "usable" unemployed into the Department's relocation operation, the so-called Job Mobility Program.

Simultaneously, plans are in the offing to herd people unsuited for either job training or relocation—the retarded, the mentally ill and chronic alcoholics—into locally coordinated labor intensive public works jobs.

Newfoundland's Labor Minister told IPS last week that the job training project was "going along quite well." The trained recipients are already being relocated in jobs; the recipient must take a job even if its 100 miles away, he boasted.

A spokesman for Canadian Manpower Department offices stated that the success of the project could "really help the 'Mobility Program' get off the ground."

Meanwhile, the Hawkesbury project in Southern Ontario is forcing recipients to attend films depicting their social obligation to work. The films are followed by an indoctrination lecture where they are told that they must make use of their skills and take whatever jobs offered them--wherever these jobs may be located.

The Manpower Department spokesman also revealed that a new slave labor program to deal with non-trainables will soon be implemented. Entitled the Community Employment Strategy this project will track workers deemed unusable for relocation into low-wage self-help jobs in community projects.

The Manpower Deparmtnet intends to extend these Nazi selection and relocation experiments to cover the entire Canadian population. In a speech this week, Manpower and Immigration Minister Andras declared that now all unemployment insurance claimants will be slotted into a selection program, and then forcibly relocated under the "Mobility Program" if they meet requirements.

A government spokesman told IPS that the only roadblock to this recycling machine is the bureaucratic separation of the Manpower and Insurance Departments. This problem is presently being remedied on the local level by an amalgamation of functions leading to their eventual merger into one manpower office. Both departments now sit on a national steering committee to oversee the operation of the pilot projects. 80 "employment market specialists" have been dispatched to provinces to work closely with the Unemployment Department. They will set up slave labor pools by funnelling worker profiles into computer banks now established in several provinces.

#### BREAKTHROUGH AT VLADIVOSTOCK?

Dec. 1 (IPS)--There is little in <u>published</u> accounts of this week's Strategic Arms Limitation Talks (SALT) agreements in Vladivostock to justify U.S. Secretary of State Henry Kissinger's description of the accord as a "conceptual breakthrough" in nuclear arms control.

As Rockefeller depresses the standard of living of the advanced sector working class, the cabal must be assured of either the total impotence or actual aquiexcence of working class parties, particularly the Communist Parties of Western Europe. This in turn means the aquiescence of the Soviet Union. The "conceptual breakthrough," as originally proposed by former CIA chief and now Defense Secretary James Schelsinger, is a means of psychologically conditioning the Soviet leadership to respond to increasing encroachments of a military and political sort on its vital interests under the threat of thermonuclear holocaust. This conditioning involves a process of approximation by "limited nuclear exchanges" involving, first, proxy nations (such as Israel or Iran) and later, the U.S. against the Soviet Union itself.

So why would Kissinger use such a precise piece of Rocke-feller strategic terminology in describing the accords? Has the Soviet Union capitulated to its own suicide and agreed to any first approximation of the "conceptual breakthrough?"

#### An Incredible Story

The published accounts of the SALT accords fail to meet even the most minimal credibility criteria in strictly military much less political, terms. Specifically, the agreement calls for establishment of ceilings respecting nuclear weapon delivery systems (intercontinental ballistic missiles --ICBMs-and strategic bombers, such as the B-52) to be set at 2500 systems for each side. The agreement further sets a limit of 1300 MIRV's for each side. A MIRV (Multiple Independently-targeted Re-entry Vehicle) delivery system allows a single missile to carry a pay-laod of severl nuclear warheads which disperse upon re-entry. Theoretically, a single MIRV could knock out several different targets.

The United States has already deployed MIRV's extensively. By 1977, it plans to have exactly 550 of such systems, with no more proposed built until the mid 1980's. Further, the U.S. proposes to have an addition 736 delivery systems of the MIRV type in the form of the submarine-launched Pseidon and Trident systems -- still under the MIRV 1300 ceiling established by the accord.

The Soviet Union has not yet even developed MIRV capability.

Of further significance, the agreements do not cover the co-called Forward Based Systems (FBS)—those delivery systems located in territory outside the national borders of the two countries. In other words, neither the hundreds of nuclear-armed U.S. and NATO fighter-bombers based in Europe, nor the smaller "non-strategic" nuclear rockets with which NATO forces are largely equipped are touched by the new accords. Brezhnev apparently did not even raise the question of FBS's in Vladivoctock, although previously it had been a major negotiating issue for the Russiands.

The simple fact is that both the U.S. and Soviet Union now operate on the principle of mutually assured destruction (MAD), that one launches all one's missiles and bombers the first moment one knows the enemy has, thereby obliterating the enemy—and the rest of the world. Both countries have more megatonnage than necessary for mutually assured destruction—in fact, mutually assured destruction many times over. The accord simply limits the amount of future megatonnage at an absurdly higher level of mutually assured destruction. The SALT agreement, from a military standpoint, is imbecility, psywar, or a cover story—or a combination of these.

The tangible effect of the agreement appears to be economic, that is, one of forcing the Soviets to develop and deploy a MIRV system to maintain parity on this score with the U.S. As mentioned, the ceiling established on MIRV's permits the U.S. to continue with its present plan for MIRV production and deployment, compelling the Soviets to do likewise. This, however, would represent a deadly drain of the most advanced electonics and laser technological sector, and would impair Soviet development in other sectors. This opens the Soviet Union to the intervention of Rockefeller's economic plan for the U.S.S.R. The Soviet Union, to finance the MIRV system, would have to accept increased trade and credit deals with the Rockefeller interests -- on Rockefeller's terms -- or face strategic inferiority.

What is most interesting about the SALT agreement is what it does not say about the two cornerstones of Rockefeller's "conceptual breakthrough": thermonuclear proliferation and the possible use of tactical nuclear weapons in the Mideast.

It is incredible that the Soviet leadership would not have been well aware of the intelligence available to any reader of New Solidarity: the fact that Israel and Iran possess nuclear weapons. Further, every indication given to New Solidarity correspondents suggests that this proliferation is not limited to these two countries. These are facts which could not have escaped the attention of Soviet military intelligence. Given the fact that the Vladivostock meeting was held at the point when Israel was implicitly threatening to hurl a nuclear warhead at an Arab population center—a fact which even the CIA's Yasser Arafat noted—the absence of note of an actual "conceptual breakthrough"—type discussion is

highly conspicuous.

As suggested by the Western European CP press, the agreement <u>could</u> represent a means by which Brezhnev can silence his left opposition, and divide certain military-technological sectors which have pushed for MIRV development. This would still mean a new "arms race" and profound problems for the Soviet Union. One thing is certain. Henry did not tell it all. And any Congressman with any sense had better find out just what did go on at Vladivostock.

# GOVERNMENT ANNOUNCES AUTO RELOCATIONS TO BRAZIL AND IRAN

Nov. 30 (IPS)--While at least 200,000 U.S. autoworkers are booted out of their jobs this winter, the government will vastly increase the rate of shipment of old auto plant and equipment to Brazil, a United States Commerce Department spokesman reported today. According to a special report prepared by the State and Commerce Departments, the spokesman stated, over \$1 billion in auto vehicle production equipment "could" be sent to Brazil between now and 1976, along with at least \$1 billion in auto parts production equipment—a clear indication that plans of this sort are being carried out.

Simultaneously, Iran National, Iran's state-owned auto industry, announced that it has negotiated a more than \$555 million investment contract with the failing Chrysler Corporation for its idle plant and equipment. The Shah, one of Rockefeller's major conduits for buying up world industry and controlling world investment, also took a controlling interest in a financially healthy part of the world auto industry this week--Daimler-Benz.

These announcements, like the daily contradictory announcements of thousands of layoffs in the CIA press conduits around the country, are not merely weapons for psychological terror. Already approximately one out of four "temporary" layoffs in the auto industry--where the number of unemployed will hit 165,000 next week--are turning out to be permanent. If Rockefeller continues to have the political freedom to turn off the credit spigot, not only the equipment, but thousands of these workers themselves will join their European and Japanese brothers in their rebuilt, antiquated factories in Iran and Brazil--implementing the massive deindustrialization of the advanced sector. This deindustrialization is a conscious strategy of the Rockefeller cabal, aimed at destroying living standards in the advanced sector and outflanking the Soviet Union's only ultimate resistance to Rockefeller takeover, the threat of nuclear destruction of the United States and Western Europe.

#### Dividing Up the Loot

The Commerce and State Departments' report on industrial relocation projects states that Brazil's auto production will increase two-and-one-half times between 1973 and 1980, while annual exports of all machinery, equipment and services to Brazil will jump to \$10 billion per year by 1978. Carried out at the expense of industry in the advanced sector, this will not represent an advance even for the citizens of the Third World, but an accelerated looting process.

Spokesman for the Treasury Department Gerald Parsky spoke last Monday before the American-Arab Association for Commerce and Industry on other plans for industrial relocation. Unlike

Brazil, the Middle East is slated to receive primarily fertilizer and petrochemical plants rather than heavy industry. In reference to projected Arabian investments, Parsky noted that one major bottleneck was the "scarcity of human resources"—a lack which a special organization "staffed by experienced foreigners" would be taking care of soon.

#### IEA ORDERS ENERGY CUTS HERE AND IN EUROPE

Nov. 30 (IPS) -- The cuts in energy consumption prepared by Rocke-feller's International Energy Agency (IEA) for a world "energy emergency" are already being implemented.

Figures released last week by the West German Tribune's Economic Affairs Review show that cuts in oil consumption in 1974 have reached 17.2 per cent in West Germany, 12 per cent in France, 8.9 per cent in Britain and nearly 7 per cent in the United States. The IEA's preliminary target is a 30 per cent cut.

Meanwhile, the heads of Canadian Energy Allocation Division and Energy Conservation Department announced that they have worked out—in coordination with the IEA—mandatory programs that will cut Canadian energy consumption by 14 per cent, including an embargo on exports of petroleum to the United States—beginning with a reduction of 28 per cent by next July.

Rockefeller thus has jumped the gun on the energy austerity drive, planned to go ahead full steam following a new oil embargo. The supranational body, whose control belongs nominally to the United States and de facto to the Rockefeller oil companies is ordering energy cutbacks while its lackeys within the governments of Western Europe and the United States are scurrying to comply.

# EAST GERMANY AND DKP DENOUNCE SCHMIDT BUT NOT HIS TRADE UNION CRONIES

WIESBADEN, BRD, Nov. 30 (IPS)--Both the German Democratic Republic (GDR) and the West German Communist Party (DKP) have added their voices to the European Labor Committees in attacking this week's meeting of multinationals, governmental figures and Trilateral Commission members in the West German trade union leadership, held from Nov. 25-27 at the offices of the Friederich Ebert Foundation in Bonn.

The Ebert Foundation is a counterinsurgency agency controlled by the Social Democratic Party (SPD). Named after the

famous German counterrevolutionary of the post World War I era, the foundation has coordinated international operations for the CIA-connected Second International, including establishing the Portuguese Socialist Party.

The official GDR radio--Voice of the GDR--in news broad-casts throughout the day Nov. 28 denounced Schmidt and West German Finance Minister Apel for their collaboration with the multis. The reports mentioned Rockefeller multis Exxon, Mobil and IBM, but not Rocky, by name. A similar scathing attack against Schmidt and the government appeared that same day in the DKP's newspaper Unsere Zeit.

The attacks, however, lost most of their potential punch by the GDR's and DKP's failure to include in their charges the Rockefeller agents in the labor movement present at the meeting. This was no "oversight"; it reflected the DKP's consistent policy of tailing Rockefeller policy--as long as it is spouted by a "trade union leader."

Thus, the same Unsere Zeit issue which denounced the Bonn meeting carried articles praising the fascist "full employment" policy of West German Trade Union Federation Chairman and Trilateral Commission member Oskar Vetter. They published a box carrying the Trilateral Commission's line on investment policy (recycling) and "full employment," written by Vetter.

Recently, Rockefeller henchmen in Europe have been quoted as saying, "We don't consider the Communist Parties a threat." If they continue to let Trilateral Commission members like Vetter set policy for them to tail, such statements will hold true.

#### NCLC STRATEGY IN UAW SUIT: PROVE WOODCOCK FASCIST IN COURT

Nov. 30 (IPS) -- Is Leonard Woodcock a fascist? This is the question which will be answered as the National Caucus of Labor Committees brings its countercharges against Woodcock and other United Auto Workers (UAW) officials in response to the latter's \$30 million lawsuit against the NCLC and the U.S. Labor Party.

NCLC legal and intelligence staffs are now undertaking a mammoth research operation in preparation for the taking of depositions against UAW officials and their co-conspirators, and for the counterclaim which the NCLC will file against UAW officials. While the NCLC will countersue Woodcock et al. for harassment, libel and conspiracy to violate elementary civil rights, the core of the NCLC's case against Woodcock will be to bring into court a mountain of evidence which will demonstrate that Woodcock is indeed a fascist and that he is also a Nuremburg criminal under conventionally accepted definitions.

The fascist character of the programs and policies which Woodcock advocates will be demonstrated by reference to the historical meaning of fascism, including both the self-definition and expert opinion about previous fascists such as Hitler, Mussolini and British fascist Oswald Mosely. The legislative and political programs advocated by Woodcock--coparticipation and other forms of corporatism, NERA "full-employment" legislation, Project Independence "self sufficiency," etc.--will be shown to be essentially identical to the programs of earlier European fascists.

#### UAW Members to Join

The second major thrust of the NCLC countercharges against Woodcock and the UAW bureaucracy will be to prove that Woodcock is committing the crime of menticide (brainwashing) against members of his union. The entire Black Lake brainwashing operation and its interconnections with the Organizational Development network will be documented and detailed in court, proving that Woodcock and other UAW leaders are complicit in using medical and psychological coercion against union members. These practices have been defined as crimes against humanity under the Nuremburg principles.

Hundreds of UAW members will be involved in gathering evidence against Woodcock and other UAW national and local officials. Any union official, shop steward or foreman who is involved in harassing workers or funnelling workers into brainwashing programs can be named as a co-conspirator and co-defendant in the NCLC counterclaim. Over the next few weeks, Labor Party organizers will be collecting evidence from workers which will be used in putting together the case against Woodcock.

#### Woodcock's Crimes in Europe

Labor Committee sections in Western Europe will also be engaged in gathering evidence about Woodcock's international connections, including the UAW's connections with the West German Social Democratic Party, with the International Metalworkers Federation and of course his collaboration with Trilateral Commission co-conspirators. The NCLC is now evaluating the possibility of filing a simultaneous suit against Woodcock et al. in Europe, since his crimes are not impeded by national boundaries.

#### Court Rules in NCLC's Favor

The UAW's request for permission to take early depositions from the NCLC and the Labor Party was denied in U.S. District Court, Southern District of New York Nov. 27. The judge noted that because the NCLC had been publishing New Solidarity since 1968, there was no expectation that the NCLC would "disappear," as the UAW had stupidly suggested. Therefore, the judge ruled the UAW cannot take depositions for 30 days.

#### WORKERS CLOSE UAW BRAINWASH CLINIC

Nov. 30 (IPS)--Reliable sources report that the UAW "alcohol treatment" section of Baltimore's Johns Hopkins' Phipps Clinic is slated to close Jan. 1, 1975. Although no official statement has yet been given out by clinic officials, the "unofficial" reason for the shutdown is as follows:

The U.S. Labor Party distributed a leaflet last month which identified the alcoholism programs at the clinic as brainwash operations directed specifically at the industrial city workers. An electric response was immediately generated, with scores of angered workers calling the clinic doctors at all hours of the day and night to inform them that these practices would no longer be tolerated. The hospital employees were buzzing about these "new revelations," clutching the leaflets in their hands.

And so the heat got higher. Dr. Ward, the head of the UAW program, initially had considered continuing the program on his own, but it has been reported that he has changed his mind.

#### ITALIAN SOCIALIST PARTY LEADERSHIP JOINS ROCKEFELLERS' TRILATERAL PLOT

Nov. 30 (IPS)--On orders from from the CIA-run Second International, the national leaders of the Italian Socialist Party (PSI) have attempted to intimidate Marcello Zoccali, leader of the "Unity for Socialism" tendency within the party, to prevent him from continuing United Front work with the European Labor Committees. Two days ago, PSI hack Spano was dispatched to Milan from party headquarters in Rome to inform Zoccali, recently widowed and with a small child, that he would be suspended from his salaried party job. Following his threats, Spano then "relented," promising Zoccali a probationary period provided he "works within the party."

Zoccali's factional organizing against Rockefeller's policies has threatened the PSI leadership who have lined up behind Rockefeller's fascist economic and political policies. Since October, each of the PSI's factional leaders--Nenni, Lombardi, DeMartino and Mancini--have openly propagandized for the "Bellagio Line," a strategy for an independent, Europe-wide, progressive fascism laid out in a secret meeting of Rockefeller agents in Bellagio, Italy that month.

#### Nenni

The first to launch the Ballagio theme within the PSI was old Pietro Nenni, hero of the anti-fascist Resistance. Nenni was harbored and funded during World War II by the notorious

Romualdi family, agents of the American secret services (OSS). Nenni took the occasion of an earlier Bellagio reunion—the meeting in late August 1974 when Italy's Premier Mariano Rumor pawned Italian gold reserves to Helmut Schmidt for a \$2 billion loan—to announce that "all the old formulas are out of date and inadequate to the serious times we are living in."

Rewriting the post-war years, Nenni hinted at the next "Marshall Plan." He speculated that if the Popular Front of the Communists (PCI) and Socialists had won the 1948 elections, Italy would have followed a policy of active neutrality, maintaining good relations with both the USSR and the United States. "We certainly would not have had to fear the dictatorship of the proletariat," he said. For the present, Nenni proposed an "emergency government" of all the parliamentary parties except the fascist MSI, needed to impose the necessary austerity on the working class.

#### Lombardi

"Left" faction leader Riccardo Lombardi allies with right-winger Nenni on the basis of the need for "anti-fascist vigilance." Lombardi, whose Resistance credentials were won in the ranks of the tiny, U.S.-sponsored Action Party of banker Ugo La Malfa (now head of the Republican Party), has made himself the spokesman of the popular front against the much-publicized CIA-directed military coup "plots" which have plagued Italy this year. In one of those principled alliances which typify summit-level PSI politics, old Resistance fighters Menni and Lombardi teamed up in September to pressure the PSI to withdraw from the government, even going to the unheard-of lengths of circulating a mass leaflet in Rome to call for the "emergency coalition."

#### DeMartino

The majority faction around party secretary DeMartino made itself officially heard for the Trilateral Commission line Sept. 13 in Bologna. The occasion was a panel discussion organized by Giorgio Amendola, the self-admitted CIA agent in the PCI Politburo. DeMartino's spokesman Vittorelli came out in enthusiastic support of European-wide popular fronts on the example of Portugal, Spain and Greece, where the CIA is busy installing "progressive" fascist regimes.

DeMartino personally launched a corporativist policy for Italy Oct. 14 by urging the imitation of the "social contract" of the British Labour Party. Ignoring the PSI's long opposition to such worker-management-government deals (based on the historic experience of Mussolini), DeMartino warned, "The gravity of the crisis and its foreseeable long duration demand politically courageous decisions...along the line taken by the [British] Labor Party." Not surprisingly, DeMartino had a "very cordial" meeting Oct. 16 with La Malfa. Now, a month later, the PSI is supporting the La Malfa/Moro cabinet which is pledged to implement the fascist economic policy of the "social contract."

#### Mancini

With DeMartino, Lombardi and Nenni firmly in Rockefeller's camp, there only remains the left-wing factions of Giacomo Mancini, Minister for the Mezzogiorno in Rumor's cabinet and long-time advocate of capital-intensive development policies for his native south. In mid-September, Mancini caved in to the threat of economic disaster and the enticement of investments on his turf by the Rockefeller-linked financiers—the Bank of European Investments, FIAT corporation, etc. Mancini began to defend labor—intensive projects in irrigation, forestation and waterworks over his former preference for capital—intensive jobs. "As far as the South goes...I have tried to separate myself from the excess of debates I would call ideological and to dedicate myself to concrete action," he said. Since then, Mancini's "concrete actions" have consisted in slave—labor projects with which, he boasts, "Italy can help to solve its monetary crisis."

Mancini himself best summarized the PSI's current program for the European working class, in a letter published Nov. 9 in the PSI daily Avanti. Talking about building a "New Society," a European federation "starting with complete autonomy," Mancini called for a "European Democratic Front" made up of "popular political forces." "The particular European situation...forces [us] to design a model of development which takes into account our direct relations with the Third World. A relationship which would overturn the traditional one of imperialism and would even provide that some of the costs may fall on the backs of the European working class, at least those parts that are better off." (Emphasis added.)

This scenario--a corporativist Europe starvings its workers in return for the privilege of financing slavery in the developing sector--is precisely the program of the Trilateral Commission.

### SUB PAY STORY: GOING, GOING, GONE

DETROIT, Nov. 30 (IPS) -- As their union Supplemental Unemployment Benefits (SUB) pay runs out, auto and steel workers are being herded directly into slave labor jobs.

In Pontiac, Mich., the local welfare office has recently made plans to employ 1,100 Pontiac General Motors workers whose SUB pay is exhausted, on local "public works" jobs. In Flint, laid-off auto workers have already been spotted working in Work Relief Employment programs. Michigan Manpower Director Donahue told IPS that the expected continued high levels of unemployment will require new statewide plans to employ the jobless in similar forced work schemes.

This is only the beginning. Hundreds of thousands of industrial workers will soon join the slave-labor manpower pool.

Although the companies, the unions and the CIA press have done their best to obscure the SUB pay picture, the facts are clear:

\*Twenty-five thousand GM workers have already exhausted their SUB pay, or will exhaust it within the next two weeks. These are mostly workers laid off nearly continuously since last January's First Great Oil Hoax. Before Oil Hoax No. 2 has gotten into high gear, January 1975 layoffs are up to an announced level of 100,000; another 30,000 workers will be off SUB pay by early February. The GM sub fund, drained to \$100 million, cannot last past the end of April. Its collapse will throw at least 40,000-50,000 more workers onto the welfare rolls.

\*Chrysler's fund is in even worse shape--only \$80 million in the till. With 60,000 Chrysler workers on layoff, the fund will run out in late February or early March--even earlier if Chrysler is bought by Rocky's Arab sheikhs and shipped to Iran.

\*Ford is slightly more solvent--\$150 million in the SUB fund and "only" 40,000 layoffs--a situation which could change rapidly.

\*The steel industry is the worst situation of all. Jay Rockefeller's United Mine Workers strike has triggered the cutoff of all steel SUB pay. As the United Steel Workers contract
makes clear, since the UMW is striking against the steel companies' own "captive" coal mines, no SUB pay will be forthcoming.
Tens of thousands of steelworkers will be practically devoid of
income and will be immediate targets for slave labor schemes, if
the CIA's UMW strike lasts much longer.

### BORDER COPS HARASS LABOR PARTY

WINDSOR, Ontario, Nov. 30 (IPS)--U.W. Labor Party organizers from Buffalo and Detroit successfully crossed into Windsor and Toronto, Ontario, Nov. 29, for a full day's organizing in which they sold several hundred copies of New Solidarity to industrial workers in the Canadian Golden Horseshoe. Extensive press coverage of the North American Labor Party electoral campaign in St. Catherine's and Toronto had forewarned border officials that they would not be able to prevent Labor Party entry into Canada.

In the final days before yesterday's Toronto and St. Catherine's municipal elections, Labor Party organizers had fought a running battle with customs officials and border police seeking to protect Rockefeller's forced slave labor plans in Canada from Labor Party exposure. The border campaign was directed by the U.S. Law Enforcement Assistance Administration (LEAA).

In Ontario, agents have been scurrying around to prevent North American Labor Party candidates Rick Saunders in Toronto and Lucylle Boikoff in St. Catherine's from repeating the 14 per cent vote of Alan Levinson in Vancouver three weeks ago.

The head of the Canadian Department of Manpower and Immigration Andras recently announced that this department's mobility program "will now force the unemployed to take the jobs we offer them...even 100 miles away." At the same time all efforts have been made to turn Canadian electoral politics into a sick joke; Andras' slave labor program was never submitted before the Canadian Parliament. Notorious agent and LEAA sidekick in the New Democratic Party Martin Schulman has come out in public support of Rosy the Clown for Mayor of Toronto.

In Canada, the Canadian Manpower (relocation) boards have succeeded in sucking in the Communist Party and the entire trade union apparatus, with the exception of the isolated resistance of the Quebec Federation of Labor. Under Andras' program slave laborers will be forced across provincial borders and will be pulled from the U.S. and from around the world to meet the labor skill requirements of Canada's redevelopment project slave labor camps.

### CIVIL DEFENSE PERSONNEL TRAINED BY CIA/LEAA

Nov. 30 (IPS)--Civil emergency defense personnel around the country are currently being sent through the same CIA training mills which spawned and "educated" the murderous Green Berets, known for their slaughter of Vietnamese peasants.

The director of the Pueblo, Colorado Civil Defense Agency, Sam Musso, told IPS this week that their new Industrial Defense Coordinator, Air Force Lt. Col. Harry Haney, is uniquely qualified for his post, having just returned from the Army's Defense Civil Preparedness Agency (DCPA) Staff College at Battle Creek, Mich. Musso was trained at the school for civil disturbances at Fort Gordon, Georgia three years ago, which is also responsible for training the Law Enforcement Assistance Administration (LEAA), the National Gestapo. He was followed by a contingent of Pueblo police and fire officials who trekked to Fort Gordon and other area officials who went to the DCPA College at Battle Creek.

According to Musso, the Military Police School at Fort Gordon, which runs the LEAA civil disturbance counterinsurgency course for LEAA agents, also runs the Schools on Emergency Planning and Industrial Defense for the DCPA, such as the one at Battle Creek. In the past, Fort Gordon has been responsible for training the CIA police Gestapos of Brazil, Indonesia, Vietnam and other Third World countries.

An official in the Emergency Services Division of the Michigan State Police, the coordinator of the State's emergency

preparedness apparatus, confirmed Musso's assertions in an interview with IPS.

The Michigan official, Lt. Milton Jury, stated that representatives of local, county and state government, police and service agencies also receive their preparedness instruction at the DCPA Staff College at Battle Creek. The training program includes evacuation, relocation and food control—all counter—insurgency methods for population control developed by British Brigadier General Frank Kitson, under the tutelage of master brainwasher John Rawlings Rees, during World War II.

Jury also revealed that the LEAA provides the funds to train DCPA, police, military and civilian personnel in LEAA-style counterinsurgency operations. Happily, he noted the increasing "day-to-day" role that the civil defense apparat is playing in civilian affairs.

### IBM PAPERS NAME NCLC

SAN FRANCISCO, Nov. 30 (IPS)—The International Association of Chiefs of Police (IACP) has collaborated with executive personnel of the IBM Corporation to produce and publicize a Pentagon Paperstype document which attempts to link the National Caucus of Labor Committees to terrorist activities and organizations. The IACP is a front group for the CIA and the Law Enforcement Assistance Administration.

The document, "IBM as a Target of Terrorism," opens with an account of supposed "real terrorist threats against IBM," and calls upon the corporation to institute "an effective intelligence system on the plans and acts of extremists and terrorists." To support that proposal, a special section of the document is devoted to the NCLC as "precisely the kind of organization that IBM should now be monitoring, using all its resources." The only other organizations mentioned by name are the CIA-directed Symbionese Liberation Army, the fascist Jewish Defense League, the American Nazi Party and the Ku Klux Klan.

The cover for the operation was a "12-day IACP training session" with top IBM executives, in the course of which the document was supposedly produced. IBM already maintains a large, well-trained security division, which serves as a major conduit for "former" CIA officers deployed into industrial security.

Under the title "The IBM Papers," the document was delivered over for publication in the Nov. 15 Berkeley Barb through agents at the so-called New York News Service--a basement recreation of Tuli Kupferberg, the semi-psychotic former member of the Fugs rock band.

The Barb publication was quickly followed by coverage in the New York Times, the San Francisco Chronicle and the San Francisco Examiner. These virtually identical articles quoted IBM officials as saying that they had no intention of implementing the "counterintelligence" measures called for in the report, thus slyly conceding that the document was a hoax intended to be "leaked" solely to slander the Labor Committees and to whip up hysteria about terrorism.

In the report, NCLC cadre are described as "truly skilled provocateurs of violence," who "attempt to organize and manipulate IBM workers." The report then mentions "work slowdowns, active disruption and sabotage and non-negotiable demands on non-wage issues such as...drugs." This species of apolitical provocation is advocated only by such brainwashed creatures as those in the CIA's own "Revolutionary Union" countergang.

#### PALESTINIAN PROPOSES RETURN TO 1947 BORDERS

Nov. 30 (IPS)--Palestinian guerrilla leader Zuheir Mohsin granted a special interview to the staid British financiers' daily the Financial Times Nov. 26, in which he laid down "conditions for a new relationship resulting in a stable and just peace" in the Middle East. Mohsin's "moderate" demands, issued immediately before he joined Palestinian Liberation Organization boss Yasser Arafat on a Thanksgiving voyage to Moscow, centered on forcing Israel to return to the original borders laid down in the 1947 United Nations mandate on Palestine.

Mohsin currently heads the right-wing Syrian-backed "Al Saiqa" guerrilla organization. Saiqa was created by the Syrian military and is little more than a Palestinian-staffed division of the Syrian army.

It is absolutely clear that Israel would not even consider such a proposal, which would "liberate" not only the territory occupied in the 1967 war, but the entire area under Israeli control since the first Arab-Israeli war of 1948. Despite the Financial Times' straight-faced presentation, the proposal is equivalent in seriousness to demands by CIA-backed Indian-liberation grouplets in the United States for Wyoming or South Dakota.

The significance of Mohsin's suggestion is that it preceded the Arafat pilgrimage to Moscow. The recent series of diplomatic reverses suffered by the increasingly enraged Zionist butchers has already provided the context for a "groundswell" at the UN in favor of the Mohsin 1947-border idea. Such a UN movement, led, of course, by the much touted "Arab-Communist-Third World" coalition, would provoke the Israelis into escalating the simmering Middle East war.

In fact, the Soviet bloc, as well as certain "Arab-leaning" European governments, might be induced to support this absurd proposal--which is exactly what the Israelis fear.

Discussions at Rockefeller's recent "Atlantic Bridge" meeting in Bonn tend to corroborate the anti-Israeli shift, including the possibility of using a NATO police force to patrol the final Arab-Israeli border after a fifth Middle East war. Under the pretext of restraining the mad-dog Israelis, this NATO Middle East force might even win the approval of the slumbering Communist Party of the Soviet Union.

# ROCKY AND N.Y. TIMES GIVE MARCHING ORDERS TO CITIES; GUT NYC BOND MARKET

NEW YORK, N.Y., Nov. 29 (IPS)—New York Times scare coverage of the New York City budget crisis has sabotaged the city's ability to borrow through the bond market, a city official admitted today. Through the Nov. 25 Times front-page article, "Experts Fear Growth in Costly City Debt," the Chase Manhattan Bank of David Rockefeller has delivered an ultimatum to the Beame administration and other cash—strapped city governments: enforce mass layoffs and cutbacks in essential services or face bankruptcy.

According to a brokerage house spokesman, the Times publicity was instrumental in discouraging investors from buying the city's latest bond issue, causing prices to plummet. An official at the City Comptroller's office has now confirmed this story. By cutting off further lending, the city's major bondholder, Chase, has backed the city into a corner where it can force further cutbacks beyond the 1,510 layoffs already announced by Mayor Beame.

### Follow Rocky's Orders

The New York Times article became explicit when it referred to the notorious Bankers Agreement of 1932: "The banks then agreed to bail New York out, but only if the Mayor took marching orders from the banks and cut the budget drastically. The city followed where the banks led."

Today's IPS interview with the spokesman for the City Comptroller's office revealed that the city already is "taking its marching orders." Concerning the Times coverage and its depressing effect on city bond sales, Mayor Beame and Comptroller Harrison Goldin reportedly have sent a letter of protest. However, the source then blurted out, "It is true that the banks have tremendous muscle....Issuing an ultimatum has been openly talked about....This is why Goldin is seeking budgetary reforms....We'd be blind not to see what has to be done. We're being told what has to be done—not in so many words—by the market and by the financial community." He added that Goldin is "in almost constant contact with the financial community."

#### THE SHAH TAKES OVER EXIMBANK

WASHINGTON, D.C., Nov. 29 (IPS)--Sources at the Export-Import Bank of the United States (Eximbank) said today that an "Arab guarantee" on U.S. exports will replace the Eximbank's own guarantee on the credit of importers of U.S. goods.

Because the Eximbank is running out of funds, sources said "an agreement of some kind will be worked out" to permit the

Arab oil countries to underwrite export credits from U.S. manufacturers.

At the moment, sources added, the Eximbank is, in effect, under the direct control of Treasury Secretary William Simon.

Since its founding 40 years ago, the Eximbank has devoted a large part of its funds to providing interest-rate subsidies for loans to the Soviet Union and other East bloc countries, to enable them to purchase U.S. goods. But Simon canned this long-standing policy last September, with an agreement to ban all state subsidies for trade deals between "developed" countries that involve loans of more than three years. According to Treasury sources, the Soviet Union is considered a developed country.

In recent trade deals, the Soviets have been compelled to accept high-interest loans for the purchase of Western goods, as a result of Simon's ban on state subsidies of trade credit.

The Eximbank's proposed "Arab guarantee" for trade financing is identical, in principle, to an offer made to the Soviets at a top level meeting on East-West trade last week in Vienna. Three Western representatives told the Russians that because of a "world capital shortage," future large-scale financing of East-West trade would have to come from the oil sheikhs, Eximbank sources said.

Privately, the Soviets have already accepted Mideast trade financing--"laundered" through Austrian and British banks, as IPS reported Nov. 16.

The aim of these proposals is to compel the Soviet Union and its allies to place increasing portions of their economic resources in hock to the Rockefeller-controlled banks and multinational corporations, directly or through the puppet oil sheikhdoms.

# TRADE UNION LEADER ADVOCATES CONVERSION OF AUTO INDUSTRY TO SERVE ROCKY'S REDEVELOPMENT

Nov. 29 (IPS)--Philip Sims, Consumer Affairs Director for the Detroit Trade Union Leadership Council (TULC), has announced his ideas on how to convert the empty auto assembly plants in the Detroit area into use-value for Rockefeller's world restructuring. Convert all the auto industry into the manufacture of road building and farm equipment, he says, to be used abroad in Rockefeller's "new" development projects. Sims cited as an example Nigeria where \$5 billion is earmarked for building roads, \$8.5 for industry and over \$4.5 billion for "other" development projects.

# SPD HOSTS ROCKEFELLER MULTINATIONALS; PLANS CORPORATIVIST POLICY

WIESBADEN, BRD, Nov. 28 (IPS)--Leading members of 50 major American-controlled multinational corporations, including Exxon, Mobil and IBM, held a highly secretive meeting in Bonn, West Germany from Nov. 25-28. The meeting, held under a cover provided by invitation from the Social Democratic Party-controlled Friederich Ebert Foundation, was attended by such notables as Chancellor Helmut Schmidt and Rockefeller's Trilateral Commission organizers in the West German trade union movement.

The participants were working out the finer details of coordinating multinational policy as defined by the previous week's gathering of the Atlantic Bridge Society. The Atlantic Bridge group, dominated by the figure of former high commissioner of occupied Germany John J. McCloy, a leading director on the Chase Manhattan international directory, determined the necessity for West German-American joint hegemony in implementing European austerity and deindustrialization.

At a press conference Nov. 27, Ernst Wolff Mommsen, chairman of Krupp, complimented SPD Chancellor Helmut Schmidt for demanding that the multinationals develop a "code of behavior" to improve their public image. The official communique quotes Schmidt as proposing that, "This [West German-American] code could at a later date become the model for a worldwide ordering."

One of the conference themes leaked to the press was the desirability of promoting openly corporativist, i.e., fascist, collaboration on economic policy between the multinationals and the trade unions. Specifically addressing the long-term organizing activity of Trilateral Commission members Eugen Loderer (president of the Metal Workers Union), Heinz Oskar Vetter (chairman of the German Trade Union Federation) and Karl Hauenschild (chairman of the Chemical Workers Union), the communique states, "...the world economic situation, and the framework in which the multinationals operate, demand a close dialogue between the unions and the management of the multinationals." Mommsen closed the press conference by noting, "The Americans seem very, very satisfied....Such willing informativeness on the part of the government, such discussion—they have never experienced this before."

# TRILATERAL AGENT SOMMER SINGS PRAISE TO BRAZILIAN GENOCIDE

WIESBADEN, BRD, Nov. 28 (IPS) -- "For South America, the Brazilian model is an inspiring initiative. Nothing in this form has ever existed before: a military government which calls upon its people

to keep extremists in its own ranks in check; above that running a capitalism which is freindly to foreigners, and which is now discovering its own social components."

These are today's words of fascist Trilateral Commission member Theo Sommer, writing in his capacity of chief editor of the NATO-allied West German weekly Die Zeit.

Providing a hint of what Brazil also has to offer to the European working class, Sommer drools: The parliamentary opposition in Brazil "decided on the financial reform and on the tax reform. It created new institutions, like the regional development organs. It introduced the indexation of wages and salaries. It created new possibilities for capital investment."

Assuring his West German readership that even its military government has an acceptable face, Sommer trills, "The last election resulted in a measure of freedom such as Brazil has never known up until now."

## FRENCH ZERO-GROWTH BLUEPRINT MAKES AUSTERITY LOOK GOOD

Nov. 28 (IPS) -- The psychological warfare attack on French workers launched in the influential French daily Le Monde yesterday was intensified today in the second part of the paper's "Residential Imperative" series. After reading this terrifying blueprint for the future, workers will welcome mere austerity and slave labor as a blessing.

The first Le Monde article yesterday proposed that France be turned into a vast farm, while workers are relocated out of the dismantled urban centers into labor-intensive agricultural work camps. The author of the series, Michel Albert, is the director of the Common Market's "Structure and Economic Development" Commission. He is writing the series in cooperation with France's Hudson Institute-linked relocation agency, the DATAR.

Part two of this futurist horror story lays out how this pastoral paradise will be run. "One of the great national objectives for 1980," Albert announced, "should be the end of the exodus from rural areas." Albert hopefully assumes that government funds for the upkeep of urban areas will be slashed, that individual capitalists will be forced to toe the no-growth line, and that "mentalities [will] change" in the face of the resulting total decay of the cities. Provided that the above occur, Albert proposed the following "development plan...to encourage the acceptance of the new conditions of industrial development."

## Education as a Weapon

New jobs will be created in small towns "or even villages." In this cozy atmosphere everyone will "know one's neighbor" (and help keep an eye on him). In addition, firms will be forced to "train their own labor force" to "prepare it for necessary changes" through a system of "permanent training." This permanent training will ensure that the workforce can be flexibly deployed to agricultural work camps in France, industrial projects in Brazil, or anywhere else. In addition, the continuous recycling of the workforce through such a system provides a perfect framework for intensively brainwashing these workers, already trapped in isolated work camps.

Albert also advocates that, in the world of the future, unions be coopted into some "collective job security" guarantees in order to help firms wring the last drop of profits out of their enslaved workers. In fact, Rockefeller's men on the scene are already pushing the gutless French trade unions into just such an agreement, which will not only force workers to relocate but make them codetermine where they will be sent.

Finally, Albert's ugly scenario underlines the necessity of drastic cuts in industrial energy consumption, leaving French workers to contemplate a future in which the new rural industries will use "all local energy, manpower, and raw materials potentials" along the lines of a "recycling of waste" program. Clearly, it is human resources that are to be used to the limit, even to the cannibalistic recycling of "wasted" workers.

## FRENCH WORK-STUDY PROJECT BRINGS BRAINWASHING TO FACTORIES

Nov. 28 (IPS)--A low-intensity brainwashing operation is underway in the north of France. University professors and local capitalists are setting up this pilot project for industry under the guise of a university work-study program.

The operation was initiated by a team of self-styled radical professors from the university in Lille, a hot-bed of syndicalist "local control" organizing. The project also enjoys the active support of the Northern Employers' Association. Under this scheme, high school graduates will be sent into factories for several months' work at minimum pay, before they go on to a university curriculum. The first experiment is being carried out with a group of 20 students; 40 firms in the area have already offered to employ voluntary student slaves.

The French daily Le Monde reported Nov. 27 that the jobs assigned to this first group of students are selected on the basis of psychological profiles. Le Monde notes that an unskilled

job would not be given to a "rebel" student who might "develop relationships within the enterprise" and organize his co-workers; instead such a job might be given to a "rather shy young girl," for instance.

### "No Nasty Bosses"

Meanwhile the team of professors, along with plant management, follows the students during their plant training session, making sure to isolate the students within specific "individual and intrapersona" -- as opposed to "collective" -- relationships.

The point? "Pampered, followed step by step, made to feel secure on a permanent basis," the brainwashed students will play an intermediary role between the chief brainwashers and workers in the plant. In addition the pilot project can be expanded both to recruit mobs of student scabs and to apply these experimental psychological techniques to industrial workers.

The Northern Employers group has this clearly in mind. One of the best-organized groups of capitalists within the CNPF, the leading French employers' association, and with ties to a number of counterinsurgent agencies, the Northern Employers group applauded the new work-study brainwashing scheme with the following comment: "We want students to have a better understanding of the world of the factory....We want youth to understand what a plant is, that there are no nasty bosses or exploited workers."
