Dollar Collapse Signalling Worst Depression in History

NEW YORK, Feb. 22 (IPS) -With the threatened dissolution of its major prop, Rockefeller's Arab oil producers' cartel (OPEC), the U.S. dollar this week entered the terminal phase of collapse. The imminent drastic drop in the price of oil - to its acknowledged current market value of approximately \$1 per barrel - will definitely seal the fate of the "wastepaper' currency, instantly plunging the world economy one giant step further into the worst Depression crisis in world history.

Seeing the handwriting on the wall, European capitalists, Latin American banana republics and Arab sheiks alike are scrambling to cut themselves loose from the dollar, hoping thereby to protect themselves from inevitable economic chaos as the linchpin of world trade and finance gives way.

Underlying this new phase in the ratchet collapse of the Dollar Empire is a grim and horrifying reality: Since October, 1974 industrial production in the United States alone has contracted at an annual rate of 40 per cent — a rate of industrial collapse that already outpaces that of the disastrous 1929-1933 Depression years.

Since Rockefeller's October Revolution — the quadrupling of oil prices in the fall of 1973 otherwise known as the Great Oil Hoax - the oil price weapon wielded by Standard Oil's frontmen in the Middle East has provided the Rockefeller faction with a means of looting real income - the equivalent of 2-3 per cent of the world working class's wage bill - to re-finance the collective debts of the world financial structure. The sheikhdoms' \$60 billion in surplus oil revenues last year, funneled into the international banking system or to governments and private corporations, papered over the gaping fissures in the world payments structure, even as production was slashed worldwide in a desperate capitalist cost-cutting

spree. Further, the \$15 per barrel price of oil promised the Rockefeller gang a healthy return — that is, a new accelerated round of looting — on the Rockefeller slave-labor "energy development" projects.

After a year of steadily contracting industrial production and the gutting of working class incomes, the accumulated glut of oil — if the factories aren't running who needs oil? — now threatens the carefully rigged oil price mechanism that was the dollar's last claim to loot, the sine qua non of a viable capitalist credit instrument.

If the price of oil falls to \$1 per barrel, the total volume of oil revenues will fall to \$10 billion. The oil-exporting countries would be immediately forced to withdraw approximately \$30 to \$40 billion in previously "surplus" petrodollar deposits from the international dollar market just to pay current bills. Amounting to more than one-sixth of total "Eurodollar" funds, this would bankrupt the Eurodollar market, the world's chief lending pool, overnight - fatally detonating the entire international monetary system.

Panicked recognition of just this fact was reflected this week in the foreign exchange markets where despite heavy support operations by the U.S. Federal Reserve, the dollar continued its month-long plunge into obscurity, registering a record low again yesterday against the Swiss franc and a 15-month low against the French franc. Italian press reports indicated that major financiers in London "linked to the Arab world" were converting substantial quantities of dollars into "especially deutsch-marks" - with the lawful consequence that the dollar fell a full percentage point against the West Germany currency!


According to foreign exchange traders contacted by IPS, this stepped-up round of dollar dumping was occasioned by the news of Algeria and Iraq's call for oil payments to be made in currencies other than the dollar. Still, as this newspaper reported last week, Washington is maintaining an official silence on the U.S. currency bust with Treasury spokesmen denying that anything would be done about the dollar.

The most dramatic display of breakaway came this week from Rockefeller's own private haven, Latin America. Desperately attempting to get some "independent" footing from which to weather the dollar · collapse, Venezuelan and Colombian finance ministers in a Feb. 15 meeting proposed the creation of an "Andean Compensation System" to serve as a clearingtrade, circumventing the usual mediation of Rockefeller's New York banks, but based at least in part on Venezuela's own soon-tobe-worthless petrodollars!

However, like the schemes for a continental "basket of currencies" newly-revived by French Finance Minister Fourcade and now circulating among panicstricken European banking circles, such "survival" gimmicks are meaningless pipedreams in the face of the fullscale rout of production and trade. Not only will the dollar collapse shortly wipe out every currency based on it - and that means every currency in the world with the sole exception of the Soviet bloc's Ruble - but since world trade is carried out in dollars, swift and massive devaluation as a result of the oil price collapse will immediately shut down that most elementary feature of economic activity, sending production into a final nosedive.

The only way to stave off the economic and ecological holocaust that will otherwise inevitably accompany the death throes of the dollar empire is the immediate collaboration of European, Latin American, oilproducing and other Third World governments with the international working class, movement to restart useful production on the basis of a Euro-Ruble trade bloc guided by the requirements for expanded world food production.

There is not a moment to lose. Right now there is no one anywhere in the world, save Rockefeller himself, his chief goon Henry Kissinger, their Domestic Council and assorted mindless lackeys in the U.S. State Department and Treasury, who seriously believes that the price of oil can be kept at the present price of \$15 per barrel. Rockefeller and his henchmen are stupid and dangerous, as was clearly indicated in the State Department's response to Japan's negotiations this week with Abu Dhabi for oil at a mere 60 cents below the current extortionate price. At a meeting of the American-Japan society in Tokyo, William Culbert, minister for economic affairs of the U.S. embassy in Japan, addressed just such a "hypothetical" situation. "I think industrial country importers of Japanese goods would have to protect themselves against imports under-priced due to substantially different energy costs...we must prevent different energy costs and the acrimony this would entail," he told the gathering, in an open selfrighteous threat of trade war.

An Offer They Couldn't Refuse

NEW YORK, Feb. 18 - Important insight into the politics of the strategic East-West trade problem is provided by comparing proposals for the expansion of such trade emanating from Helsinki, Finland and London. Tempting though it might be to dismiss the package deal British Prime Minister Harold Wilson took with him to Moscow - especially considering that the proposed deal was checked out first in the U.S. with representatives of the Rockefeller-Ford clique, and that results were cleared with travelling towel-boy Henry Kissinger as the latter stopped off in London on the return leg of his latest rally round the Middle East - such an approach is insufficient (under present conditions). What is needed in the international workers' movement at this point is a sensuous understanding of the politics of the East-West trade issue.

Let's clear away the secondary issues first. Despite the press mileage which the CIA's psywar division will undoubtedly extract from the sheer magnitude of the projected deals between Britain and the Soviet Union — in excess of \$2 billion — and notwithstanding Comrade Brezhnev's undoubtedly sincere desire to help British workers by putting them to work on Soviet contracts, such deals will not significantly affect the international strategic situation.

The reason for this is located in the domain of politics, not in the economics of the expansion of East-West trade per se. From the layman's standpoint the proposed exchanges of British capital goods for Soviet raw materials may seem to meet the requirements which the ICLC has generally specified in the 'Real Detente' and 'Zuerst kommt das Fressen' proposals. Closer examination shows that they do not. The reason is not hard to find. It is the political role of capitalist credit and finance in such arrangements which has to be understood.

From the capitalists' standpoint production and consumption of socially necessary goods and services is merely a by-product of their actual business at hand. What is primary is the extension of credit in anticipation of projected returns on the extension of such credit. However, returns are not calculated from the basis of the actual social cost of necessary production, but rather on the basis of maintaining the purely paper value content of the credit originally advanced. In consequence as advances in social productivity depreciate the value of credit advanced in terms of real cost to society, the continuing demand for return on the credit advanced begins to strangle the production of necessary goods and services.

No sane person could any longer deny that such is the case from a mere cursory survey of the present state of capitalist economics as such. The mere juxtaposition of idled plant, construction equipment, deteriorating housing, transit and education facilities, with everspiralling corporate municipal and state indebtedness demonstrates the point.

However the situation in regard to such arrangements with the Soviet Union and East Bloc countries is marginally different. These areas actually reppresent, from the capitalist standpoint, a source of previously unaccounted loot, within existing credit systems, available to prop up credit and monetary systems which are presently collapsing from the weight of debt we have noted above. Over the short-run, advances of capitalist credit to such areas will no doubt result in potential advances in so far as raw materials etc. are actually freed for the production process. In the not-so-short run such practices acutally serve to subjugate production within the workers' states areas to the dictates of capitalist finance.

It's from that vantage point that the mooted deal between Bri-

tain and the Soviet Union must be seen. Unless Harold Wilson has agreed to recognize the reality of his government's position by bankrupting the pound sterling, then Soviet raw materials, despite good intensions, will merely serve to back up the pound in its international monetary system role as pilot fish for the economically toothless shark that the U.S. dollar has become. Unless the pound were bankrupted and the deal made on the basis of development plans dictated by the political working class, the Soviet-British arrangement could fall into the same category as David Rockefeller's erstwhile "detente" deals.

The issue here is really quite simple. Simple strengthening of economic ties between workers' states and capitalist sectors does not inevitably rebound to either the Rockefeller faction's or the working class' political advantage. All that is necessary for the workers' movement is to recognize the reality of the situation. The capitalists' political situation, in particularly Western Europe, is such that the workers' movement is admirably positioned to begin to make the kind of political offers the capitalists cannot refuse. Simply put, the political strategy to adopt in pursuit of expanded East-West trade is to use the political and social unrest generated by the insane economic policies of the Rockefeller faction in the industrialized West as the lever to implement trade and production proposals modeled on the urgent need of the Soviet Union and the East Bloc countries to upgrade the social productivity of their agriculture, and of the Western countries themselves

The Finnish **Proposals**

It is from the standpoint of such a strategy that the current political impact of the proposal for the incorporation of the Soviet Union in an expanded Scandinavian trade and energy bloc, launched by Finnish Social Democrats through their newspaper Demari must be seen. The rationality of such a proposal is demonstrated by the hysterical response it has drawn from leading Swedish and Danish Social-Democratic operatives of the CIA like Palme, Anderson and Norgard, whose present policies of militarized economies on the basis of the NATO controlled output of North Sea oil fields is presently the target of working class hatred throughout the region. In short the Finnish proposals have forced Palme into publicly demonstrating the reality of his policies - without verbiage. A

Conservative was deployed to Rejkyavic, Iceland to rebutt Finnish proposals, while Palme himself told Labor Committee organizers at Copenhagen's airport that he would join NATO "tomorrow."

Of course the mere creation of disarray within the ranks of ruling capitalist factions in that part of the world does not, in itself, take this necessary process further forward. The practicality of the Finnish proposals must be developed from the standpoint of the convertible Ruble

arrangement, coupled with the necessary Handelsbank to assure satisfaction of Soviet agriculture and other production priorities. Such activity must in turn be accompanied by workers' movement efforts to demonstrate the urgent feasibility of such proposals in the eyes of the workers themselves. Following such a path the Finnish 'pilot model in the expansion of East-West relations' can become in short order a giant step in the transition to workers' government forms in Europe as a whole.

Is It 1965 All Over Again?

An Analysis of Senator Sam Nunn's Report to the Senate Armed Services Committee: Vietnam Aid-- The Painful Options

Feb. 18(IPS)--Faced with an economic crisis that dwarfs that of the 1930s, the Rockefeller family has opted for massively increased military production-the militarization of the economy-as the "sclution." This is established fact. From the Fiat plants in Italy to the Chrysler plants in the United States, from the increased shipments of arms to the Persian Gulf area to the increase in arms procurements called for in Department of Defense budget now before the Congress for authorization, billions of dollars are being poured down the military production sinkhole to avoid bankruptcy of the international monetary system.

It is in this context that the demands being made by Vice-President Nelson Rockefeller and his top mouthpieces, President Gerald Ford, Secretary of State Henry Kissinger and Secretary of Defense James Schlesinger, for continued U.S. military involvement in Vietnam--in direct violation of the word and spirit of the 1973 Paris Peace Accords--must be seen.

Yet, the implementation of this policy is not so straightforward, especially where it pertains to Vietnam, for it must be implemented over the international working class' counter-demands for tractors and food. The necessity of diluting those counter-demands, a necessity which is the invariant feature of capitalist policies in a depression period, has forced the Rockefellers and their spokesmen into an attempted revival of the Cold War, hoping to first force the U.S. Congress to vote against the voice of their anti-war constituency, out of fear of the well-known "Rockefeller muscle," and second to spread anti-Communist hysteria among the working class. This is the purpose of Senator Sam Nunn's report to the Senate Armed Services Committee, "Vietnam Aid -- The Painful Options."

These insane polices can be defeated only by arming the working class with the programmatic alternatives, but nonetheless useful to publicly expose the naked fraudulency and outright lies that permeate Senator Nunn's documents, which is nothing more than a thin cover for Rockefeller depression policies.

Senator Nunn's report, prepared for the Senate Arms Services Committee following the Georgia Democrat's recent trip to South Vietnam, purports to be a justification for a limited increase in U.S. military aid to the South Vietnamese Government (GVN) of President Nguyer Var Thieu. In actuality it is a justification for an indefinite increase in U.S. military aid for an indefinite period into the future.

1965 Lies Revived

The reasoning Nunn employs for his seemingly "limited" aid

proposals is taken directly from arguments used by Kennedy, Mc-Namara, Johnson and the CIA in the pre-1965 phase of the Vietnam war to gradually increase U.S. involvement, up to the 1965 introduction of ground troops and aerial bombardment of North Vietnam. In fact, the Nunn report strikingly resembles the 1965 Government White Paper, a similarly mendacious document which justified the involvement of United States Army and Air Force combat personnel by portraying the situation as an invasion by North Vietnam into the sovereign nation of South Vietnam.

In this vein, the report portrays the present situation as a military problem, not a political one, in order to motivate further U.S. military assistance. It claims that the question of who broke the cease-fire first cannot be determined, as both sides are guilty but that recent actions by the North Vietnamese forces, plus alleged North Vietnamese intentions, "by their own admission" demonstrate that North Vietnam (DRV) has now scrapped the Paris Accords and is pressing for the total defeat of the South. South Vietnam is portrayed as fighting for its survival as a nation; there is not one mention of the Provisional Revolutionary Government, while Thieu's regime is always referred to as "the South Vietnamese," in direct violation of the wording of the Paris Accords. Finally, the report

dredges up the threat of a post-war bloodbath if the Saigon regime is defeated, and uses this image to threaten Congress with ultimate responsibility for the outcome if increased military aid is not granted.

CIA Sources

As proof of the above allegations, Senator Nunn cites "information made available by U.S. officials in Saigon" while ignoring the substantial and powerful evidence, now in preparation as a brief to Congress by U.S. Labor Party, that Thieu immediately began major abrogations of the Accords as soon as they were signed. A phone call to Nunn's office revealed that Nunn conferred with the CIA in Saigon, which was at least one source for Nunn's allegations. Moreover, while Nunn makes no reference to them by name, his quotations of the PRG and North Vietnamese are alleged "captured Communist documents," released by the U.S. Embassy last month; copies of these documents are in possession of U.S. Labor Party. Nunn's quotations from and summaries of the documents establish the "captured documents" as Nunn's cited source. It is interesting to note that Nunn's summaries of the documents match those written by the CIA and the State Department.

We will now proceed to demonstrate, by a simple comparison of Nunn's distorted summaries and selected quotes with the actual text of the "captured documents," that the claims Nunn makes in his report of North Vietnamese aggression, supposedly proven "by their cwn admission" are totally false. We will also show that the actual intent of Nunn's distortions is to serve as a "foot in the door" to increased military spending.

The Nunn report asserts, "By their own admission the North Vietnamese have made it clear they have no intention of working to revive the 1973 Paris Accords but are determined instead to press for the total defeat of the South by any means at their disposal." (p.3) The report then refers (p.3) to the full text and later appends of the U.S. diplomatic note of January 3, 1975 issued by the State Department, which charged the DRV and the PRG with flagrant violations of the Paris Peace Accords. This diplomatic note is much the same as the summaries affixed to the "captured documents" by the CIA or State Department. The note lists a series of alleged violations by the North Vietnamese, thus exonerating Thieu for all responsibility for breaking the Accords, and labe. the defensive measures of the PRG as original provocations and violations of the Accords.

The report consistently harps on the claim that all Saigon needs is more ammunition, arguing that the North Vietnamese supplies in the South are much larger than Saigon's. It maintains that " "South Vietnam has little chance to survive without aid from the United States." (p.9) The report calls for the upgrading of South Vietnam to "an equivalent position with the North as to ammunition, fuel, spare parts and medical supplies." Estimates of these equivalents will come from the CIA of course, which leaves the door wide open for as increases in military spending. In fiscal year 1978, the U.S. will then agree to limit its resupply to"a level comparable to the estimated military and economic aid to the North and will not exceed that level." Again it is the CIA which will make the estimates in 1978. Moreover, the vague word "c: parable leaves the door open to contin ed military spending.

Domino Theory

The Nunn report goes so far as to use "dor ino theory" re-soning claiming, "One thing is certain --if South Vietnam falls because they have run out of ammunition we will all find out the effect on the American position throughout the world." Then, trying to make the elected representatives forget the demands of their own constituencies, Nunn says, "If South Vietnam is overrun because America cuts off ammunition, fuel and spare parts, and thousands of South Vietnamese are killed or executed, the burden may shift to those who advocated the cutoff to justify this action." And finally, in the most blatant revival of Cold War rhetoric contained in the document, Nunn writes, "The Soviet Union and the Chinese will be served notice that their clients will not win the war by default of the U.S." (p. 16)

When the "captured documents" are read closely, an honest evaluation only shows that there exists no basis for the official United States Government and Senator Nunn's evaluation of them; the lengths to which the Communists go to stress their willingness to implement the 1973 Peace Accords will undoubtedly surprise the The key thing to note is that, while the U.S. Government reader. and the Nunn report claim that the PRG are intent on overthrowing the South Vietnamese Government in total disregard of the Paris Accords, the documents themselves say that Thieu must be replaced before honest implementation of the Accords can take place. The PRG claim in the documents that they made attempts to work with Thieu but his flagrant violations of the Accords, directly after they were signed, has made this impossible. It is on this point that the United States Government and Senator Nunn are most guilty

of distortions, lies and omissions.

Distortions of PRG Stated Policy

The documents, issued in the early fall of 197., are named COSVN Directive 08 (COSVN - Central Office For South Vietnam), and Resolution of the Binh Dinh Province Party Committee Conference. respectively. Directive 08 claims that the PRG is responding to provocations by Thieu and are acting out of self-defense. In the first noteworthy section, that of responsibilities in the near future, the document outlines the "tasks of disrupting pacification," referring to programs such as Operation Phoenix and the Strategic Hamlets, which are aimed at wiping out PRG influence in the countryside. All pacification programs are illedal under the Paris Accords. Then, after a lengthy section outlining "the enemy's plans for continued implementation of the pacification programs, the goal of ending "U.S. dependence" and achieving a "peaceful, independent, democratic, neutral, and prosperous South Vietnam to advance peace and nitional reunification" is advocated.

It is in the second document, the Resolution of the linh Dinh Party Committee that the actual policy of the PRG becomes more clear. While the PRG policy of self-defense against the provocations of Thieu and their intention of forcing the replacement of Thieu with someone who is willing to implement the Peace Accords is made quite clear in the document, both the U.S. Government and Senator Nunn choose those quotes, which when taken <u>out of context</u> imply a PRG strategy of war against the government of South Vietnam as a whole.

The document begins, "American imperialists, defeated in aggressive war, were forced to sign the Paris Accement and withdraw their troops from Vietnam. They changed from using American troops to using puppet troops, the Puppet Government, and U.S. advisors to continue the war. The principal strategem is "Pacification" by encroaching to seize land and people..." This is the very first paragraph yet Nunn makes no mention of it.

What is referred to very often is the following,"We must not delude ourselves that we can negotiate peace or reconciliation with the .hieu clique. We ought to struggle decisively to defeat the new colonialism of the American Imperialists and decisively conduct a class struggle to overthrow the Thieu regime...We have no choice but to use violence, to start the war..." (p.2) But only when this statement is seen within its proper context is its actual meaning apparent. Most significant, the document shows how unprepared the PRG was for Thieu's immediate abrogation of the Accords. "At the beginning we did not make a complete assessment of the enemy's stubborn nature and his strategic scheme to continue 'Vietnamizing' the war by signing the Paris Agreements and at the same time continuing the war..." (p.11) "Only when the capitalist comprador, bureaucratic, militarist and fascist American Puppet Government is overthrown and replaced by another force which is willing to implement the Paris Agreement is there a possibility that peace can be restored." (p.15)

Thus by massive, selective omission, an entirely false impression is created by the United States Government sum.ar.es and the report prepared by Senator Nunn for the Senate Armed Services Committee. While the summaries affixed to these documents and Senator Nunn's report are designed to the same purpose as was the spurious evidence used to construct the 1965 Government White Paper, this timely exposure will prevent them from being used. This exposure together with the Brief to Congress now being prepared by the U.S. Labor Party, documenting the continued violations of the Peace Accords by dictator Thieu, shows that the biggest block to the implementation of the Peace Accords has been the Thieu It further shows that only when the United States governregime. ment exercises its well-known dominant influence within the existing South Vietnamese government will the honest implementation of the 1973 Paris Peace Accords come about.

W. GERMAN PRESS CONFIRMS KISSINGER ARRANGEMENT OF TURKISH ARMS DEAL

WIESBADEN, Feb. 20 (IPS)-- West Germany's leading daily, the Frankfurter Allgemeine Zeitung, today explicitly confirms that U.S. Secretary of State Henry Kissinger was instrumental in arranging West Germany's supply of arms to Turkey with the intention of overriding the U.S. Congress' resolution prohibiting such supplies. The Allgemeine reports, "The resumption of German weapons supplies to Turkey was discussed during Kissinger's meetings in Bonn, and supported by him. Kissinger made no secret of his rejection of the Congressional resolution on weapons supplies to Turkey."

The Allgemeine also reports that the Federal Republic intends to resume arms supplies to both Turkey and Greece, "although the government does not, in general, send arms to tension-ridden areas." These arms supplies in a crisis area are a direct violation of the West German Constitution.

support the Geneva Peace Conference, American press sources today headline Secretary of State Henry Kissinger's fears that Syria will play the role of "Arab spoiler," sabotaging his bilateral approach to peace settlements. Syrian officials reportedly are mobilizing against the possibility that Syria will be excluded from an Egypt-Israel agreement, amid signs that Kissinger's formerly easy manipulation of Arab-Israeli politics has given way to recent Soviet and Iraqi initiatives.

KISSINGER BEGS FOR WAR

NEW YORK, Feb. 21 (IPS) -- U.S. Secretary of State Kissinger discussed the possibility of Israeli bombing raids against Arab oil installations with Israeli officials during his recently concluded trip to the Middle East, UPI reporter Thomas Cheatham cabled from London today. "Israeli government officials have begun to speak publicly," added Cheatham, "about the likelihood of aerial bombardment of Arab oil wells in case of a new war in the Middle East."

U.S. THREATENS TRADE WAR IF JAPAN TAKES CHEAP OIL

Feb. 21 (IPS) -- The U.S. State Department has openly threatened trade war against Japan should the latter accept oil price cuts from any of the OPEC countries. The threat was made by William Culbert, Minister-Counseller for economic affairs of the U.S. Embassy in Japan in a public speech before the American-Japan Society in Tokyo.

GENSCHER/MORO MEETING; NATO DISCUSSED ON MEDITERRANEAN POLICY

MILAN, ITALY, Feb. 22 (IPS) -- West German Foreign Affairs Minister Hans-Dietrich Genscher is presently meeting with Italian Premier Aldo Moro in Rome, ostensibly to discuss West German-Italian trade agreements and color television system contracts. However, reports point to the "military" content of the talks. Vittorio Brunelli, Corriere Della Sera correspondant on German affairs, stressed on Feb. 20 that Italy is the "bridge country" between the Mediterranean and the trouble spots of Northern Africa implicitly suggesting that Genscher and Moro are not discussing color television but military preparations for intervention in the Middle Fast.

KENNEDY ARMS PROPOSAL WOULD CONVERT WESTERN EUROPE TO MILITARY PRODUCTION

The thrust of this effort will be to counter "various sources" which have accused the Soviets of complicity with the U.S.

IRAQ ORGANIZING AGAINST U.S./IRAN

Feb. 23 (IPS) -- Saddam Hussein, Deputy Chairman of pro-Soviet Iraq's revolutionary command council, has proposed a joint naval defense agreement with Saudi Arabia in order to counteract the growing military presence in the Persian Gulf of U.S. supported Iran, according to an interview in the Egyptian newspaper Al Ahram. The interview was published one day before the opening of the Asian Peace Forces Conference in Baghdad, Iraq, which is bringing together socialist and communist forces from across Asia and the Middle East.

SOVIETS SUPPORT IRAQ AGAINST IRAN

Feb. 23 (IPS) -- An article on the CENTO military alliance in the Soviet army newspaper Krasnaya Zvezda Feb. 21 clearly draws the class lines between Iran and Iraq. Pointing out that Iraq's decision in 1958 to leave the bloc constituted a "tangible blow" to imperialist strategy for the Near and Far East. The commentary describes moves to strengthen CENTO against a "threat of Soviet expansion."

OIL PRICES TO DROP...U.S. PRICES TO RISE

Feb. 18 (IPS) -- Two adjacent front-page articles in today's New York Times reported that oil prices would be dropping and world crude oil prices have already begun to sag in response to reduced consumption by the industrialized nations, which has created a worldwide surplus estimated from 2 million to 7 million barrels a day. Some countries like Libya and Algeria have reduced the official price of their oil; the second cause of the falling prices is "hidden discounting" by other producers and some oil companies.

MAIN SAUDI PIPELINE SHUT AS ROCKY/OPEC CUT OIL PRODUCTION FURTHER

Feb. 19 (IPS) -- Hit hard by the massive and growing oil surplus on the world market -- estimated by a leading Washington-based oil economist at over three million barrels a day -- the Rockefeller/OPEC oil cartel was forced to shut down entirely the giant Tapline oil pipeline running from Saudi Arabia to the Mediterranean, according to CBS Radio today. An earlier report in the Wall Street Journal claimed that Tapline had been running at only 10 per cent of capacity in recent months.

"FRANTICALLY REACHING FOR A LOT OF PIECES"

Feb. 20 (IPS) -- In an interview today, Jack Bridges, oil and energy expert at the CIA-connected Georgetown Center for Strategic and International Studies and recently returned from meetings in Vienna of the Organization of Petroleum Exporting Countries (OPEC), commented that "We're just frantically reaching for a lot of pieces," when asked what plans were afoot to establish a co-ordinated energy-economic policy internationally. "Simply speaking," Bridges added, "the world has changed."

ABU DHABI INCREASES OIL PRODUCTION

Feb. 21 (IPS) -- Accelerating the demise of the Organization of Petroleum Exporting Countries (OPEC) as a Rockefeller-controlled cartel for strangling oil production and exports, the Persian Gulf sheikhdom of Abu Dhabi "has ordered western oil companies to increase production immediately...in a move that could push down the price of its high-quality oil."

DOLLAR DROPS AS OIL PRODUCERS PROPOSE REPLACEMENT

Feb. 21 (IPS) -- The dollar fell yesterday and this morning, reaching record new lows against most European currencies, amid reports that oil-producing nations desire to eliminate the quotation of petroleum prices in dollars. Kuwait may soon calculate oil prices on the basis of the dollar's exchange rate with five European currencies and the Japanese yen and Algeria and Iraq propose that an unspecified currency replace the dollar to set oil prices. Iran has called for the automatic indexation of oil prices to a world inflation rate, following the dollar's one and one-half per cent fall against the International Monetary Fund's Special Drawing Rights.

DOMESTIC COUNCIL SPOKESMAN GOES APE OVER PROSPECT OF LOWER OIL PRICES

Feb. 21 (IPS) -- Mr. Duvall, the Associate Director of Nelson

Rockefeller's Domestic Council, tol IPS today that the announced intentions of Abu Dhabi and other producer nations to lower world oil prices was a threat to U.S. control over "energy resources". After a full year of saying that the OPEC high price had caused economic disarray in the U.S., the spokesman reversed position and said that "a lower world oil price is bad, because it would increase our dependence on Mideast oil." "We need to have control," he said, "and for this we have to pay a high price so as to avoid being dependent on their oil."

RUMOR ARABS OFFER REDUCED PRICE OIL TO QUEBEC

Feb. 22 (IPS) -- The Quebec city daily, Le Soleil, reported on Wednesday that an unnamed oil producing country has offered Quebec long-term oil supplies at a guaranteed price 10 per cent below the lower international price.

WASHINGTON "UNCONCERNED" ABOUT DOLLAR COLLAPSE

Feb. 24 (IPS) -- New York Times financial columnist Edwin Dale today reports that U.S. Treasury and Federal Reserve Board officials have "no sense of alarm or deep concern" about the rapid collapse of the dollar.

The British agreed to make available \$2 billion to the Soviets at low interest rates over the next five years to finance trade between the United Kingdom and the USSR. The Financial Times fears, however, (and rightly) that the pound may be bankrupted in the meantime.

BRITISH FINANCIAL CIRCLES PANIC AS INDUSTRY FLOCKS TOWARDS SOVIET DEAL

WOODCOCK PUSHES WAR PRODUCTION OVER STRIKES

ST LOUIS, Feb. 20 (IPS) -- Under the direction of Leonard Woodcock, United Auto Workers Union members are breaking the strike of International Association of Machinists (IAM) workers here against the McDonnell-Douglas Corp., which produces F-15 fighter planes, in order to guarantee war mobilization. The U.S. Air Force ordered 729 of these fighter planes from McDonnell-Douglas, and a partial delivery is now due.

Nineteen thousand IAM workers walked out Feb. 10 against McDonnell-Douglas, in St. Louis and California plants, demanding a 10 per cent per year wage increase and protesting the low wage increase in their contract. Directed by Woodcock, UAW workers at the California plant, where they are a majority, crossed picket lines of 7,000 IAM workers.
